Para 1.20	<p>After 2 years of having to cancel or postpone fund raising due to Covid. The charity has once again managed to raise sufficient funds during the year to cover the annual expenses of insurance and maintaining the playing field and play equipment. Plus it has started building back its financial reserves. This income has made it again possible to further develop a more inclusive play equipment improvement and replacement strategy.</p> <p>A second memorial bench in memory of one of the former villagers has been paid for and erected by the family. Both these memorial benches replaced benches that had become unsafe and needed replacing. The installation of these benches has saved the charity money.</p>
