Trustees' Report

The trustees present the annual report together with the financial statements of the Charity for the year ended 31 December 2022.

Objectives and activities

Objects and aims

The Charity was established by a legacy endowment in the late 19th century. The objects of the Charity were established as, and remain as, the provision of health, welfare and education and the provision of facilities to deliver such charitable objects for the young, poor and others in and around the area of Easthorpe, Southwell, Nottinghamshire.

Public benefit

The trustees confirm that they have complied with the requirements of section 17 of the Charities Act 2011 to have due regard to the public benefit guidance published by the Charity Commission for England and Wales and that its objects are entirely charitable.

Achievements and performance

The Charity's policy is to make grants to individuals who may have financial, health or learning difficulties in order to provide facilities or therapies that will assist their conditions and similarly to make grants to organisations to assist with particular projects or facilities. The Charity aims to support particular projects rather than providing assistance to groups or individuals for day-to-day maintenance or running costs. Examples of such grants to individuals include assistance with supportive IT equipment, rehabilitative therapeutic treatments such as horse riding and adaptive home improvements. Funds have in the past been donated to a local charity providing facilities for adults with learning disabilities and the Cub and Scout Association for camping equipment. The trustees meet four times a year to consider grant applications by reference to published criteria; applications are also assessed over email between such meetings when necessary.

Financial review

The total income received by the Charity amounted to £19,553. After deducting the expenses of £6,703, the charity's surplus from charitable activities was £12,850. After the profit made from sale of building £220,000 and the unrealised loss on investment of £45,467, the charity made a surplus of £187,383 for the year.

As at the year end, Charity's accumulated fund amounts to £1,253,853 which solely includes general unrestricted funds.

Investment policy and objectives

Following consultation with users the Charity took the decision during the year to sell Easthorpe Hall (the adjoining caretaker's cottage was sold in 2021). Rental income from the Hall and its use had declined in recent years (to two sessions per week) and in turn the lack of income and the ongoing costs of property ownership and maintenance meant that keeping and running the Hall was having a significant detrimental effect on the Charity's finances with little benefit for the local community. The trustees also took the view following consultation with the users that these users were able to find suitable alternative premises for their activities and that the incurrence of significant capital expenditure to the Hall in order to upgrade the facility were not justified.

The Hall was sold after professional advice as to the sale prices being the full market value.

The trustees have taken the view that ownership and rental of the remaining portfolio of agricultural land and the allotments on Crink Lane and investment, on the advice of an IFA, of the proceeds of sale of the Hall and cottage is the best way to maximise the income of the Charity and minimise the cost of maintaining its investment portfolio and thereby for the Charity to achieve its objectives. The trustees seek to maximise the income from capital of the Charity in order to use that income to meet those objectives. The trustees intend to maintain and grow the capital available to the Charity in line with inflation.

Structure, governance and management

Nature of governing document

In accordance with the Charity's governing document there are 5 trustees, two trustees nominated by Southwell Town Council and three co-opted trustees including the Chair. The trustees meet four times a year to consider and review the Charity's finances and investments, matters of ongoing administration and publicity (including the use of a website link through the Town Council in order more effectively to deliver on the Charity's objectives). The Charity is currently an unincorporated association under a trust deed going back to 1961 but the trustees have reached the decision to seek registration with the Charity Commission as a Charitable Incorporated Organisation (CIO) which the trustees believe will better facilitate the delivery of the Charity's objectives.



Notes to the Financial Statements for the Year Ended 31 December 2022

1 Accounting policies

Statement of compliance

The financial statements have been prepared in accordance with the second edition of the Charities Statement of Recommended Practice issued in October 2019, the Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland (FRS 102) and the Charities Act 2011.

Basis of preparation

Easthorpe Common Lands Foundation meets the definition of a public benefit entity under FRS 102. The accounts (financial statements) have been prepared under the historical cost convention with items recognised at cost or transaction value unless otherwise stated in the relevant note(s) to these accounts.

Going concern

The trustees consider that there are no material uncertainties about the Charity's ability to continue as a going concern.

Income and endowments

Investment income

Dividends are recognised once the dividend has been declared and notification has been received of the dividend due.

Expenditure

All expenditure is recognised once there is a legal or constructive obligation to that expenditure, it is probable settlement is required and the amount can be measured reliably. All costs are allocated to the applicable expenditure heading that aggregate similar costs to that category. Where costs cannot be directly attributed to particular headings they have been allocated on a basis consistent with the use of resources, with central staff costs allocated on the basis of time spent, and depreciation charges allocated on the portion of the asset's use. Other support costs are allocated based on the spread of staff costs.

Charitable activities

Charitable expenditure comprises those costs incurred by the Charity in the delivery of its activities and services for its beneficiaries. It includes both costs that can be allocated directly to such activities and those costs of an indirect nature necessary to support them.

Support costs

Support costs include central functions and have been allocated to activity cost categories on a basis consistent with the use of resources, for example, allocating property costs by floor areas, or per capita, staff costs by the time spent and other costs by their usage.

Governance costs

These include the costs attributable to the Charity's compliance with constitutional and statutory requirements, including audit, strategic management and trustees meetings and reimbursed expenses.

Taxation

The Charity is considered to pass the tests set out in Paragraph 1 Schedule 6 of the Finance Act 2010 and therefore it meets the definition of a charitable company for UK corporation tax purposes. Accordingly, the Charity is potentially exempt from taxation in respect of income or capital gains received within categories covered by Chapter 3 Part 11 of the Corporation Tax Act 2010 or Section 256 of the Taxation of Chargeable Gains Act 1992, to the extent that such income or gains are applied exclusively to charitable purposes.

Fixed asset investments

Fixed asset investments, other than programme related investments, are included at market value at the balance sheet date. Realised gains and losses on investments are calculated as the difference between sales proceeds and their market value at the start of the year, or their subsequent cost, and are charged or credited to the Statement of Financial Activities in the period of disposal.

Unrealised gains and losses represent the movement in market values during the year and are credited or charged to the Statement of Financial Activities based on the market value at the year end.

Cash and cash equivalents

Cash and cash equivalents comprise cash on hand and call deposits, and other short-term highly liquid investments that are readily convertible to a known amount of cash and are subject to an insignificant risk of change in value.

Fund structure

Unrestricted income funds are general funds that are available for use at the trustees discretion in furtherance of the objectives of the Charity.

The objects of the charity were established as, and remain as, the provision of health, welfare and education and the provision of facilities to deliver such charitable objects for the young, poor and others in and around the area of Easthorpe, Southwell, Nottinghamshire

Public benefit

The trustees confirm that they have complied with the requirements of section 17 of the Charities Act 2011 to have due regard to the public benefit guidance published by the Charity Commission for England and Wales and that its objects are entirely charitable.

Achievements and performance

The Charity's policy is to make grants to individuals who may have financial, health or learning difficulties in order to provide facilities or therapies that will assist their conditions and similarly to make grants to organisations to assist with particular projects or facilities. The Charity aims to support particular projects rather than providing assistance to groups or individuals for day-to-day maintenance or running costs. Grants of £1,560 were made this year: horse riding lessons for an individual requiring rehabilitative therapeutic support and kitchen equipment for an almshouse in Southwell to assist a local charitable trust. The Trustees meet four times a year to consider grant applications by reference to published criteria; applications are also assessed over email between such meetings when necessary.

Financial review

The total income received by the Charity amounted to £10,254. After deducting expenses of £19,077, the Charities' net deficit from charitable activities was £8,823. After the profit made from sale of building £275,00 and the unrealised gain on investment of £6,979, the charity made a surplus of £273,156 for the year.

As at the year end, Charity's accumulated fund amounts to £1,066,470 which solely includes general unrestricted funds.

Investment policy and objectives

Following consultation with users the Charity took the decision during the year to sell both Easthorpe Hall and the adjoining caretaker's accommodation. Rental income from the Hall and its use had declined in recent years and in turn the lack of income together with the ongoing costs of property ownership and maintenance meant that keeping and running the Hall and cottage was having a significant detrimental effect on the Charity's finances with little benefit for the local community. There were also increasing regulation burdens involved with the provision of residential accommodation and legal action had become necessary against a tenant.

Professional advice was sought as to the sale price of the cottage being the full market value. The sale was successfully completed during the year.

The trustees have taken the view that ownership and rental of the remaining portfolio of agricultural land and the allotments on Crink Lane and investment, on the advice of an IFA, of the proceeds of sale of the hall and cottage is the best way to maximise the income of the Charity and minimise the cost of maintaining its investment portfolio and thereby for the Charity to achieve its objectives. The trustees seek to maximise the income from capital of the Charity in order to use that income to meet those objectives. The trustees intend to maintain and grow the capital available to the Charity in line with inflation.



The trustees meet four times a year to consider and review the Charity's finances and investments, matters of ongoing administration and publicity (including the use of a website link through the Town Council in order more effectively to deliver on the Charity's objectives). The Charity is currently an unincorporated association under a trust deed going back to 1961 but the trustees have reached the decision to seek registration with the Charity Commission as a Charitable Incorporated Organisation (CIO) which the trustees believe will better facilitate the delivery of the Charity's objectives.

Notes to the Financial Statements for the Year Ended 31 December 2021

1 Accounting policies

Statement of compliance

The financial statements have been prepared in accordance with the second edition of the Charities Statement of Recommended Practice issued in October 2019, the Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland (FRS 102) and the Charities Act 2011.

Basis of preparation

Easthorpe Common Lands Foundation meets the definition of a public benefit entity under FRS 102. The accounts (financial statements) have been prepared under the historical cost convention with items recognised at cost or transaction value unless otherwise stated in the relevant note(s) to these accounts.

Going concern

The trustees consider that there are no material uncertainties about the Charity's ability to continue as a going concern.

Income and endowments

Income generated on running allotments for local people and renting out feilds are accounted for on an accruals basis, when it is probable that the income will be received.

Deferred income

Deferred income represents amounts received for future periods and is released to incoming resources in the period for which, it has been received. Such income is only deferred when:

- The donor specifies that the grant or donation must only be used in future accounting periods; or
- The donor has imposed conditions which must be met before the Charity has unconditional entitlement.

Investment income

Interest on funds held on deposit is included when receivable and the amount can be measured reliably by the Charity; this is normally upon notification of the interest paid or payable by the bank. Dividends are recognised once the dividend has been declared and notification has been received of the dividend due.

Expenditure

All expenditure is recognised once there is a legal or constructive obligation to that expenditure, it is probable settlement is required and the amount can be measured reliably. All costs are allocated to the applicable expenditure heading that aggregate similar costs to that category. Where costs cannot be directly attributed to particular headings they have been allocated on a basis consistent with the use of resources, with central staff costs allocated on the basis of time spent, and depreciation charges allocated on the portion of the asset's use. Other support costs are allocated based on the spread of staff costs.

Notes to the Financial Statements for the Year Ended 31 December 2021 (continued)

Charitable activities

Charitable expenditure comprises those costs incurred by the Charity in the delivery of its activities and services for its beneficiaries. It includes both costs that can be allocated directly to such activities and those costs of an indirect nature necessary to support them.

Support costs

Support costs include central functions and have been allocated to activity cost categories on a basis consistent with the use of resources, for example, allocating property costs by floor areas, or per capita, staff costs by the time spent and other costs by their usage.

Governance costs

These include the costs attributable to the Charity's compliance with constitutional and statutory requirements, including audit, strategic management and trustees meetings and reimbursed expenses.

Taxation

The Charity is considered to pass the tests set out in Paragraph 1 Schedule 6 of the Finance Act 2010 and therefore it meets the definition of a charitable company for UK corporation tax purposes. Accordingly, the Charity is potentially exempt from taxation in respect of income or capital gains received within categories covered by Chapter 3 Part 11 of the Corporation Tax Act 2010 or Section 256 of the Taxation of Chargeable Gains Act 1992, to the extent that such income or gains are applied exclusively to charitable purposes.

Fixed asset investments

Fixed asset investments, other than programme related investments, are included at market value at the balance sheet date. Realised gains and losses on investments are calculated as the difference between sales proceeds and their market value at the start of the year, or their subsequent cost, and are charged or credited to the Statement of Financial Activities in the period of disposal.

Unrealised gains and losses represent the movement in market values during the year and are credited or charged to the Statement of Financial Activities based on the market value at the year end.

Cash and cash equivalents

Cash and cash equivalents comprise cash on hand and call deposits, and other short-term highly liquid investments that are readily convertible to a known amount of cash and are subject to an insignificant risk of change in value.

Fund structure

Unrestricted income funds are general funds that are available for use at the trustees discretion in furtherance of the objectives of the Charity.
