(B) TO ESTABLISH OR SECURE THE ESTABLISHMENT OF A CENTRE AND TO MAINTAIN AND MANAGE, OR TO CO-OPERATE WITH ANY LOCAL STATUTORY AUTHORITY IN THE MAINTENANCE AND MANAGEMENT OF SUCH A CENTRE FOR ACTIVITIES PROMOTED BY THE NEIGHBOURHOOD CENTRE IN FURTHERANCE OF THE ABOVE OBJECTS.

WE PROVIDE VARIOUS ACTIVITIES OF OUR OWN SUCH AS: PLAYGROUP, PLAYScheme (SUMMER AND EASTER) YOUTH ACTIVITIES, COMPUTER TRAINING, ELDERLY ACTIVITIES.
