**Objects:** (A) TO PROMOTE THE BENEFIT OF THE INHABITANTS OF THE QUEENSWAY, BROADWAY, DUFFIELD ROAD, ST HELENS STREET, FORD STREET, FRIAR GATE, SOUTH STREET, PONSOMBY TERRACE, AMBROSE STREET, LARGES STREET, YORK STREET, VERNON STREET, FOWLER STREET, REBECCA HOUSE AND THE NEIGHBOURHOOD WITHOUT DISTINCTION OF SEX OF OR OF POLITICAL, RELIGIOUS OR OTHER OPINIONS BY ASSOCIATING THE LOCAL AUTHORITIES, VOLUNTARY ORGANISATIONS AND INHABITANTS IN A COMMON EFFORT TO ADVANCE EDUCATION AND TO PROVIDE FACILITIES IN THE INTERESTS OF SOCIAL WELFARE FOR RECREATION AND LEISURE-TIME OCCUPATION WITH THE OBJECT OF IMPROVING THE CONDITIONS OF LIFE FOR THE SAID INHABITANTS.
