(D) IN OTHERWISE PROMOTING THE EDUCATION (INCLUDING SOCIAL AND PHYSICAL TRAINING) OF SUCH PERSONS. FOR FURTHER DETAILS PLEASE SEE CLAUSE 22 OF THE SCHEME.
