I would like to make particular mention of Ian and Jaqueline Harrison. Ian had the unenviable task of chairman of the village hall committee during the height of the pandemic with all of the restrictions that came with it. He and Jaqueline did a fantastic job in keeping the hall in tip top condition with the particular problems that a building that was not regularly used can throw up. Ian originally took on the role for just 12 months whilst a more permanent chairman was found but this, in fact ended up as almost three years.

We now have a very able new chairman in Cathie and already, now that the restrictions due to Covid have been eased we are seeing the Village Hall back playing its role as the centre of Village life. Helen has now left the village after many years as a pillar of the community in many areas as well as the village hall, but I am very pleased to say that Helen agreed to stay on as a trustee and I am sure that she will be able to continue to make a valuable contribution to us all.

The trustees of Charlecote Village Hall are very fortunate in having such an active, talented and youthful management committee. It means that we can be confident that all will run smoothly and the future of the village hall is in safe hands.

I would like to thank you all for the huge amount of effort that you put in and looking around at our splendid hall and seeing the large number of events that take place here I think that you must be doing a pretty good job.


