Chairman and Trustee Review of Financial Year 2020-21

In line with so many other organisations our year was defined by the impact of the Covid pandemic. All of our usual activities were suspended, and our regular monthly meetings did not take place.

However, in response to the impact of the pandemic, the Association launched a Community Covid Support Scheme for those in our local community who were most vulnerable to Covid. Working with the village and local traders, we were able to collate residents shopping orders and arrange for deliveries to be made to the residents through a team of volunteers.

This included receiving payment from the residents and then distributing the payments to the individual traders. The Community Covid Support project continued through the entire year. This led to a significant increase in the amount of money transacted by the Community Association, exceeding £29,000 in the year.

This sum included two grants amount to £3925: £3425 from Chester West and Chester Council and £500 from the Local Counsellors Discretionary Fund.

During the year we also were able to launch our Grow your Own Sunflower activity for local residents and also launch the Heart of Handbridge Calendar 2022 project.

We are indebted to everyone who supported our Handbridge Covid Community programme and particularly to Julie Rowland for taking on the onerous responsibility, with the numerous volunteers and members of St Mary's Handbridge Church in organising the coordination and dealing with the local trader community.

We were disappointed that the HCA Christmas Fair became a victim of the pandemic after such a successful and popular 'first' event in December 2019.

I wish to express my thanks for the support we received from the local community during this period and for the hard work of our volunteers.
