Report of the trustees for the year ended 31 March 2021

The trustees present their report and the financial statements for the year ended 31st March 2021. The trustees who served during the year and up to the date of this report are set out on the cover page.

Structure, governance and management

The unincorporated charity has a constitution dated 5th October 1978 as amended 11th October 1994.

The affairs of the charity are managed by its executive committee which meets regularly. Appointment of members to the executive committee is made by annual election at the Annual General Meeting.

Objectives and activities

The objects of the charity are to provide or assist in the provision for the inhabitants of the area of benefit, facilities for recreation and leisure time occupation in the interests of social welfare, with the object of improving the conditions of life for the said inhabitants. The main activity of the charity is the management and maintenance of the Llanilar Community Centre.

Achievements, performance and future work

The centre has been closed to all sports and social activities since late March 2020. We received many enquiries from both residents and neighbouring communities about reopening the centre during the periods between lockdown, but due to the many responsibilities needed under the Covid-19 rules, it was decided to play safe and restrict the use of the centre, although a full Risk Assessment was carried out.

Since March 2020 the use of the hall has been restricted to medical use, being made available to Llanilar Surgery who used it for the annual flu vaccination and for Covid-19 vaccine clinics, which remain ongoing. We continue to be extremely thankful to Mr Loxdale for his generous donations and to Llanilar Community Council for their continuing financial support by covering our annual insurance costs. We are extremely grateful to our caretaker and volunteers, many of whom serve on our small but nevertheless effective Committee, for their valuable work throughout the year. So much goes on behind the scenes to keep the centre going; not helped by working within tight financial constraints with many maintenance tasks carried out on a voluntary basis.

Financial Review

The main financial risks to the charity are being unable to raise funds for future major renovations of the property and reduced use of the facilities.

The committee seeks to retain sufficient reserves to finance future repair and renewals costs of the hall building, and to meet any unforeseen expenditure that may occur, by retaining any surpluses generated annually. Unrestricted cash funds at 31st March 2021 were £51,448.

Grants totalling £21,000 were received from Ceredigion County Council towards the running costs of the hall during lockdown. Our income this year has been applied to the running costs of the building and of making it available for use up to the lockdown, and for restricted use under Covid-19 regulations subsequently.


