Para 1.17 and 1.19	<p>Provision of the hall for hire for local interest groups and individuals on a non-profit making basis. The Trustees note that the Hall Hire income has increased by 52% (from £1,446.50 to £2,709.00) over the prior period, despite the hall not being available for hire for the last month of the year owing to renovations works.</p> <p>Staging of events to raise funds for the village halls ongoing maintenance and in support of other charitable causes in the village and local community. The Trustees note that Fundraising income has increased by 367% (from £751.55 to £2,754.47) over the prior period.</p> <p>The Trustees note that the free monthly drop in coffee mornings have continued to be successful in providing a sense of community in the village. The Village Hall Committee now provides a basis for the wider village events, previously staged by a separate organisation, giving a more co-ordinated programme of events for the local community.</p> <p>During the year the hall was subject to an extensive renovation project. This project was financially supported by the following organisations:</p> <ol style="list-style-type: none"><li>1. Gazeley UK Ltd [funding from the "Lutterworth Area Community Fund"]</li><li>2. Harborough District Council</li></ol>

		<p>3. Bitteswell with Bittesby Parish Council In addition a number of local residents made donations. The Trustees wish to express their thanks to all those parties for their support and generosity.</p> <p>The renovation project is now complete (as at the time of filing this report) and has been completed within the budgeted funding. Review of the charity's financial position at the end of the period	Para 1.21	<p>At the end of the financial period the charity held cash reserves of £31,888,82.</p> <p>Committed unbilled expenditure on the renovation project at the end of the period amounted to £27,189.22. Committed grants and donations for the renovation project not received during the period amounted to £9,000. The adjusted free cash reserves on this basis amounted to £13,699.60. The renovation project has now completed (post period end) within budget, leaving the charity with cash in excess of the below noted reserve level.</p> <p>Overall the charity recorded a profit of £1,785.37 for the period (adjusted to exclude renovation related income and expenditure) which compares favourably to the small loss of £129.07 for the prior period.</p>
