Structure, Governance and Management

The Trust was registered, by Trust Deed, in 1979 although the Rotary Club itself was founded in 1922, 102 years ago. (Charity number: 508851).

The Trust has 3 Trustees who are supported by the 48 Rotarian Club members. The Trustees are those persons who are for the time being the President, Treasurer and Secretary of the Rotary Club. The management of the Club is undertaken through the Club Council, which includes the three Trustees, which meets monthly (except August) and takes all key decisions affecting the Club. These meetings are fully minuted. The Club Council is chaired by the President. The report of the Treasurer is submitted to each Club Council meeting. The Trustees are supported in their management of the Club by the leads of the various committees, currently International and Foundation, Community Service, Membership and Fellowship, Sports and Social, Vocational and Youth Services

The Trustees confirm that they are satisfied that the current management structure of the Club mitigates the major risks to which the charity is exposed and are content with the arrangements.

No Rotarians in the Club receive any remuneration from the Club or any expenses.

The trust does not own any land or property.

As a Rotary Club the Southport Club is part of the wider Rotary family, district 1180, covering parts of the NW of England and a part of N Wales

Rotary within the district has a well-established training programme for prospective and existing Trustees.

Objectives and Activities

The objective of the Rotary Club of Southport Trust Fund is the relief of the poor & needy or such other charitable purpose, institution, society or object as the club shall in duly constituted meeting from time to time direct. The Trustees achieve the charitable objectives by: -

Making grants to local and national charities.

Supporting International Charities, particularly through Rotary International, such as ShelterBox.

Volunteering and stewarding for community causes, Queens Court Hospice support

All awards made by the Charity during the year were in furtherance of the aims of the Charity.

Public benefit: The Trustees confirm that they have complied with the duty in section 17 of the Charities Act 2011 to have regard to public benefit guidance published by the Charity Commission.

Financial Review

The books of account of the charity are maintained by the Treasurer of the Rotary Club, who is also a Trustee. The funds of the charity are held in cash or in a charity account. No donations made to the charity are currently restricted in their application.

The Charity has very little financial risk, as if income reduces, the number of awards made will decrease proportionately. And the Club has very little by way of standing charges. The major risk overall is that the Club members, as in many other Clubs, are growing older, a situation which has caused a significant number of other Rotary Clubs to disband. The Club continues to support several overseas charities, particularly where this can be done through Rotary International to give assurance that the monies are spent on the agreed objectives- e.g. ShelterBox and Polio Plus.

During this reporting year the Trust benefitted from a legacy of £38000 from a former Rotarian. This takes income during the year to £62,150. The legacy also coincided with the centenary year when there was extra fund-raising activity. The income in the reporting year is therefore well above the threshold for the submission of a Trustees' Annual Report. This legacy has no restrictions or stipulations and therefore the Rotary Club has a wide discretion as to its future disbursement.

Future Plans

The Rotary Club will continue to raise funds both from its members and from the public, principally through monthly collections at Morrisons. The leads of the various committees are the main sponsors of proposals for making grants to individuals or organisations. Several ideas have been put forward for the spending of the recent legacy and it is expected that much of the legacy will have been allocated, if not spent, during the next financial year. The Trustees continue to encourage the Committee leads to be as active as possible in seeking proposals, whilst at the same time maintaining the standards of achievement needed to be successful in applying for a grant.

Year Ended 30 June 2023

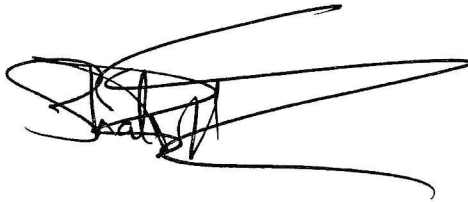

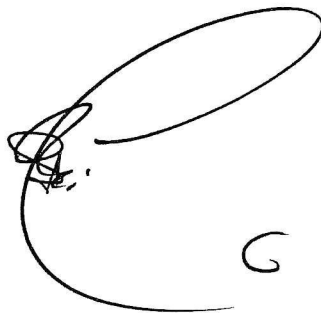
