We also take part in a local parade which really helps with our recruitment along with the club spirit, dressing up and have a laugh with eachother along with giving back to our local community as its something watched by thousands.

The charity recruits its members from a significant section of the community at large. Everyone aged 10 to 26 year can be a member of Winksley cum Grantley Young Farmers Club in order to participate in activities and discussions that increase their knowledge of agriculture, crafts rural affairs and country life. The charity actively recruits its members, aged 10 to 28 years, from a catchment area of 5 miles of Grantley.

The club activities also contribute to and create leisure activities for members and on occasion for the rural community in which the charity operates. The community around the charity benefits from our members being active citizens that contribute to the rural community.
