During the year, the Group delivered a balanced and inclusive programme of Scouting activities designed to support the development of young people in line with the aims of The Scout Association. Weekly section meetings, camps, outdoor adventures, skills training, and leadership opportunities were provided for children and young people aged 4–14. These activities helped participants build confidence, resilience, teamwork, and practical life skills while encouraging positive citizenship and personal responsibility.

The Group also supported adult volunteers by providing training, safeguarding guidance, and opportunities to develop their skills so they could deliver safe, high-quality Scouting.

In planning and delivering these activities, the trustees have had due regard to the Charity Commission’s guidance on public benefit.

Achievements and performance

Summary of the main achievements of the charity during the year

4th Hucknall Scout group has had another successful year. We continue to teach young people the many useful skills for life that Scouting is all about.

Currently we have 70 young people in Squirrels (14), Beavers (14), Cubs (19) and Scouts (23).

A few of the things we've done this year;

- This year started with NESST, with Beavers, Cubs and Scouts walking around Walesby Forest and surrounding area. We will be doing it again in 2026, thank you to all those who have already signed up.
- In March one of our members appeared on the stage at Theater Royal as part of Nottingham Scout and Guide Gang Show. Auditions for the next show will be Autumn 2026
- Beavers and Cubs visited the local fire station. We continue to look for opportunities to engage with the local community.
- Scouts, Beavers and Cubs all took part in Water Days at Hoveringham, and we are all signed up for 2026.
- At the end of June we had our Group Camp, learning many of the core Scouting skills like pioneering, den building, and camp fire songs
- In September we joined Scouts from across Ashfield for District Camp. Taking part in many adventurous activities likes laser tag, rifle shotting, and climbing. As well as enjoy an 70's rock band.
- In October we took part in Oligopoly in Nottingham City. Everyone had fun, with one of our teams coming second overall. Can they go one better next year.
- Finally next week we will have our Christmas Party at Clip'n'Climb. Thanks to all the money raised by our fantastic swimmers, we are able to offer this event at no additional cost.

All these activities means we've awarded over a thousand badges in the last year (1029). Including two Cubs who achieved every single Cub Badge and have already made a good start on the Scout badges.

24 Young People achieved the top award in each section. 8 Chief Scout's Acorn Awards, 7 Chief Scout's Bronze Awards, 8 Chief Scout's Silver Awards, 1 Chief Scout's Gold award.


