TO MAINTAIN THE ESTABLISHMENT OF A COMMUNITY CENTRE AND TO MAINTAIN AND MANAGE, OR TO CO-OPERATE WITH ANY STATUTORY AUTHORITY IN THE MAINTENANCE AND MANAGEMENT OF SUCH A CENTRE FOR ACTIVITIES PROMOTED BY THE ASSOCIATION AND ITS CONSTITUENT BODIES OF FURTHERANCE OF THE ABOVE OBJECTS

**Activities:** To associate with Local Authorities, voluntary organisations, clubs, groups, associations and individuals to provide Community Hall facilities with the objectives of improving the education, community spirit, fellowship and well-being of the inhabitants of Bicton Heath and the neighbourhood and by maintaining the Community Hall in a condition fit for such meetings and activities.
