Background

The Feldon Charitable Trust (The Trust), founded and first registered in 1981, owns the listed building being the former church of St Paul and St Peter at Winderton, Warwickshire. The purpose of the Trust is to upkeep and maintain the former church building in good order.

The Trustees

The Trustees regularly visit the church building to keep a watchful eye on the condition of the building and meet whenever necessary to discuss any upkeep or repairs that need doing to preserve the building. There are no formal sub committees as such.

Review of the Year

The Trustees consulted a local chartered surveyor who had surveyed the building in 2020 as a result of some minor cracks that had appeared at the north west corner of the building in particular. The suspected cause was either excessive root growth from nearby trees and or the blocked drainage system. In 2022 the cracks widened somewhat and the trustees with the permission of the diocese completely replaced the drainage system around the building with a soakaway into the nearby roadside ditch. The work was completed in October 2023. The cost of £23,585 was met by a generous donation as the cost was not covered by the insurance policy. At the same time as the drainage works were commissioned the Trustees followed the advice of the surveyor to install internal and external gauges to monitor any further movement on a quarterly basis in order to determine whether the cracking was caused by seasonal or permanent factors. The costs of this on-going quarterly monitoring are included under repairs and have been met partly from existing cash resources and partly from fund raising locally. During the year it was decided not to use the building for fundraising activities until the cause of the cracking was identified. Since the year end the cracks have narrowed somewhat which indicates that the causes maybe seasonal depending on the levels of rainfall.

The major items of Repairs & Maintenance expenditure were:-

Drainage replacement	£23,585
Surveyor costs	£2,220

The annual insurance premium was £4,504

The financial result of the Trust was a deficit of £2,157 for the year compared to a surplus of £962 the previous year which highlights that the charity is very dependent on donations.
