Church Stretton and South Shropshire Arts Festival

Report of the trustees for the year ended 31 August 2024

The Trustees present the annual report and accounts for the year ended 31 August 2024. The Trustees are satisfied with the performance of the charity during the year, consider that the charity is able to continue its activities during the coming year and that the charity's assets are adequate to fulfil its obligations.

Objects and activities of the charity

Extract from the Constitution of the Arts Festival

"The objects of the festival shall be to promote, improve, develop and maintain public education in the furtherance of the following objects: appreciation of the arts and sciences of music, opera, ballet, drama, film, literature, painting, drawing, photography and sculpture in all their aspects by the presentation of public concerts, performances, arts exhibitions and in such other ways as the festival Committee shall from time to time determine."

Strategic aims of the Arts Festival

1. To hold a festival in and around Church Stretton run by volunteers with a core of major high-quality events to include concerts, drama, talks, poetry, art, crafts, photography, workshops and other creative and artistic endeavours.
2. To retain a core offer while annually having some experimentation such as new types of art, event or performer so that the Festival –
 - remains vibrant and interesting;
 - adapts to changing tastes; and
 - provides a continuing attractive offering for regular and first-time attendees.

Activities – 2023-24

The Trustees are satisfied with the planning and delivery of the 2024 Festival which took place between 26 July and 10 August inclusive. The Festival, as in earlier years comprised three elements:

- An art, crafts and photography exhibition running for almost the entire two weeks
- A series of nine free concerts - six "coffee concerts" in the first week and three organ recitals in the second
- Eleven ticketed events spread over the two weeks. This was deliberately a smaller number than in 2023. In reviewing the 2023 Festival, the Committee decided that offering 15 ticketed events in that year, while successful in terms of ticket sales and audience feedback, had brought undue pressures on some Committee members and others involved. The Committee agreed that offering 10 or 11 ticketed events is more feasible.

During the year, the Committee benefited from new members. This introduced new skills experience and ideas. The Committee also commenced the steps to convert the current, unincorporated charity to a Charitable Incorporated Organisation (CIO).

Achievements and performance

The Committee was very pleased with the reception given to the Festival:

- The exhibition had over 1300 visitors over the two-week period who viewed over 1000 entries, with sell out workshops and a very well-attended portrait painting demonstration
- Six of the 11 ticketed performances were sold out or almost sold out
- Attendance at the free concerts was particularly good

As in 2023, the main venues used were St Laurence's Parish Church, the Parish Centre, St Lawrence Primary School, the Silvester Horne Institute (SHI), and Concord College. The Committee is very pleased to continue its long-term relationship with the Primary School and is always grateful for being able to use the excellent theatre at Concord College. In 2024, the Committee was delighted to work with the owners of Acton Scott Hall to host a family outdoor theatre event. This was blessed with fine weather, sold out and very well received. Another departure was a success: offering two popular music events with dancing to a live band. The talk was moved to the evening; it is clear that talks work better when held during the afternoon as in earlier years.

With the benefit of a critical learning review of the 2023 Festival, significant changes were made to how volunteers were recruited and deployed to plan and deliver the ticketed events and free concerts. This introduced many changes (differently structured roles and responsibilities) which the Committee knew would import risk. The new arrangements largely worked well; there are learning points to refine how these roles work together and are planned for future years.

Structure, governance and management

Governance

The Festival is governed and managed by a Committee who are volunteers. The Committee draws on the huge experience, enthusiasm and commitment of more than 60 volunteers who come together to demonstrate that the Festival is an event run by the community for the community.

The Charity has no employees or any contractors. No payments other than reimbursement of travel and incidental costs incurred by trustees were made to the trustees.

The Committee recruits trustees by means of advertising in the local "Stretton Focus", developing interest among volunteers and members and seeking expressions of interest at Festival events.

In addition to the trustees, the Committee also benefited hugely from the presence and contribution made by three invitees: Graham Cossins who brings invaluable advice, guidance and input on a wide range of "technical" matters; Catherine Thomas who led on popular music events and Gloria Partridge who led on marketing until she had to stand down in April 2024 for personal reasons.

Charity structure

During the year, the Committee decided to move the charity to a Charitable Incorporated Organisation (CIO) structure to reduce the financial and legal exposure of the trustees which is associated with the current, unincorporated charity structure. This decision will be enacted through formal processes to start in autumn 2024. A CIO should reduce these risks, help attract future trustees and enable the charity to continue on a more resilient basis.

Risk

The Committee wishes to record its very warm thanks to all those who have contributed to the Festival in any way including the members of the Festival – without such support and commitment, the Festival simply would not happen. The Committee is very well aware that it relies on the huge input, enthusiasm and skill of a few key people. This remains a continuing risk and the Committee continues to address this in various ways.

Following the review of the 2023 Festival, the risks to which the charity is exposed were addressed. It was clear that some volunteers were being asked to carry unnecessary responsibilities as regards first aid and fire evacuation: the Festival had previously decided to provide “cover” beyond what was specified by venues. The new arrangements are fully compliant with terms and conditions of hire and have worked well. Furthermore, in 2023, one lead role at events was hugely overloaded and brought undue pressures on an individual. This year, those responsibilities have been spread among several volunteers and again have generally worked well.

The fragility of the Festival team this year was well demonstrated; two people occupying lead roles were either unwell or suffered a family issue causing them to withdraw temporarily during the Festival. One other volunteer suffered an accident. All these absences were covered by others who willingly and generously gave extra time or were immensely flexible. These examples illustrate this key risk but also show the amazing commitment of everyone who gives their time to the Festival.

Financial review

The Charities Acts require the Trustees to prepare financial statements for each financial year which give a true and fair view of the state of affairs of the charity as at the end of the financial year and of the surplus or deficit of the charity. In preparing those financial statements the Trustees are required to:

- select suitable accounting policies and apply them consistently;
- make judgements and estimates that are reasonable and prudent: and
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charity will continue in business;
- state whether applicable accounting standards and statements of recommended practice have been followed, subject to any material change.

The Trustees are also responsible for maintaining adequate accounting records which disclose with reasonable accuracy at any time the financial position of the charity and which are sufficient to show and explain the charity's transactions and enable them to ensure that the financial statements comply with the Charities Acts. They are also responsible for safeguarding the assets of the charity and for taking reasonable steps for the prevention and detection of fraud and other irregularities. The Committee has agreed a reserves policy and aims to maintain reserves at the agreed level of £40,000.

The Festival does not have any grant income from either local or national sources.

The charity achieved a net surplus on the year of £11,300. A small working surplus is essential as the Festival has to meet some costs upfront each year ahead of generating any income. The charity's reserves stand at £56,200 compared to £44,900 at the end of 2022-23 financial year.

These results are very rewarding –

- there were fewer ticketed events than 2023 but the uptake of tickets was generally strong
- donations from the free concert series were very high at almost £3,000
- sponsorship exceeded the target at £5,600
- the exhibition produced a net surplus of £5,800, the best result for over the last decade especially bearing in mind that in 2019 and earlier years, the exhibition did not bear premises hire costs as they were accounted for the whole Festival which then was largely based at the Secondary School



The Trustees present the annual report and accounts for the year ended 31 August 2023. The Trustees are satisfied with the performance of the charity during the year, consider that the charity is able to continue its activities during the coming year and that the charity's assets are adequate to fulfil its obligations.

Activities – 2022-23

The Trustees are very satisfied overall with the planning and delivery of the 2023 Festival which took place between 29 July and 12 August inclusive. The Festival, as in many previous years comprised three elements:

- An Arts, Crafts and Photography exhibition running for almost the entire two weeks
- A series of nine free concerts - six "coffee concerts" in the first week and three organ recitals in the second
- Fifteen ticketed events spread over the two weeks

During the year, the Committee strengthened governance arrangements for the Festival and the charity which is commented on further below.

Achievements and performance

The Committee was very pleased with the reception given to the Festival:

- The Exhibition had over 1100 visitors over the two-week period who viewed over 900 entries, with sell out workshops and very well-attended demonstrations
- Eight of the 15 ticketed performances sold out and others were almost at capacity
- Attendance at the free concerts was very good

As in 2022, the main venues used were St Laurence's Parish Church, the Parish Centre, St Lawrence's Primary School, the Silvester Horne Institute (SHI), and Concord College. These venues generally worked very well.

The Committee and lead people for various activities worked very hard to arrange the events held in the evening at the SHI. A new requirement introduced by Church Stretton Town Council was for a Personal Licence Holder to be present for the sale of alcohol at that

venue. The Committee is immensely grateful to Ray Philpotts who took on this role which he also performs for the Stretton Players. The Committee was pleased to meet 50% of the costs of the necessary training and certification for this role.

The audience numbers at the SHI had to be capped at lower levels than hitherto. A late decision by Church Stretton Town Council caused by new fire evacuation arrangements and banning use of the balcony area by audiences, led to rapid changes to event arrangements. Again, the Festival teams worked really hard to deal with this in a constructive manner.

The Festival had a presence at two community events in Spring 2023 – Strettfest and the Fun Day. On both occasions this was an awareness-raising exercise although some tickets sales were made.

The relationship with St Lawrence's Primary School has developed into a longer-term arrangement which will bring mutual benefits – a continuing home for the Exhibition at the School and in 2023 joint promotion of school pupils' artwork through the Festival Exhibition including this year a colouring competition which attracted 30 entries. Also in 2023, the Committee was pleased to support "Arts Award Discover" which enabled all Year 2 pupils at the School to enter for this award and receive a certificate which among other things begins their accumulation of UCAS points. The School and the charity have also arranged joint storage facilities at the School site which is of long-term benefit to both parties.

Structure, governance and management

The Festival is governed and managed by a Committee who are volunteers. The Committee draws on the huge experience, enthusiasm and commitment of more than 70 volunteers who tirelessly come together to demonstrate that the Festival is an event run by the community for the community.

The Charity has no employees or any contractors. No payments other than travel and incidental costs incurred by trustees were made to the trustees.

During the year, the Committee completed a programme to review and update all of its documentation and policies adding some new policies, notably as regards safeguarding.

The Committee as always carried out a review of the Festival to gather learning points both positive and negative and reviewed various risks.

The Committee wishes to record its very warm thanks to all those who have contributed to the Festival in any way including the members of the Festival – without such support and commitment, the Festival simply would not happen.

The Committee has accepted the resignation of two trustees – Joan Arnfield with effect from 13 August 2023 and Sandra Whitlock with effect from 31 August 2023. Their hard work, sage advice and enthusiastic contribution will be sorely missed. With the loss of these two key individuals along with others stepping back from key roles, the Committee will review the risks and capacity to deliver Festivals in 2024 and beyond. The Committee is very well aware that it relies on the huge input, enthusiasm and skill of a few key people. This remains a continuing risk and the Committee will continue to address this in various ways.

The Committee recruits trustees and others by means of advertising in the local “Stretton Focus”, developing interest among volunteers and members and seeking expressions of interest at Festival events and promotional opportunities.

The charity achieved a net surplus on the year of £638. A small working surplus is essential as the Festival has to meet some costs upfront each year ahead of generating any income. The charity's reserves stand at £44,900 compared to £44,200 at the end of 2021-22 financial year.

These results are very rewarding given the reduced income from some ticketed events held at the SHI; the lower cap on numbers almost certainly led to reduced ticket sales given the demand experienced and the ticket “waiting lists” that had to be managed. The Committee estimates the total loss of income at about £2,000. During the year, the charity acquired a storage facility to amalgamate and store securely equipment and materials previously held at Committee members' homes. This was a one-off outlay of slightly under £3,500.

There was excellent work in generating sponsorship from local businesses and individuals. Report of the trustees for the year ended 31 August 2023

The Trustees present the annual report and accounts for the year ended 31 August 2023. The Trustees are satisfied with the performance of the charity during the year, consider that the charity is able to continue its activities during the coming year and that the charity's assets are adequate to fulfil its obligations.

Objects and activities of the charity

Extract from the Constitution of the Arts Festival

"The objects of the festival shall be to promote, improve, develop and maintain public education in the furtherance of the following objects: appreciation of the arts and sciences of music, opera, ballet, drama, film, literature, painting, drawing, photography and sculpture in all their aspects by the presentation of public concerts, performances, arts exhibitions and in such other ways as the festival Committee shall from time to time determine."

Aims of the Arts Festival

1. To hold a festival in and around Church Stretton run by volunteers with a core of major high-quality events to include concerts, drama, talks, arts, crafts, photography, workshops and other creative and artistic endeavours.
2. To retain a core offer while annually having some experimentation such as new types of art, event or artiste so that the Festival –
 - remains vibrant and interesting;
 - adapts to changing tastes; and
 - provides a continuing attractive offering for regular and first-time attendees.

Activities – 2022-23

The Trustees are very satisfied overall with the planning and delivery of the 2023 Festival which took place between 29 July and 12 August inclusive. The Festival, as in many previous years comprised three elements:

- An Arts, Crafts and Photography exhibition running for almost the entire two weeks
- A series of nine free concerts - six "coffee concerts" in the first week and three organ recitals in the second
- Fifteen ticketed events spread over the two weeks

During the year, the Committee strengthened governance arrangements for the Festival and the charity which is commented on further below.

Achievements and performance

The Committee was very pleased with the reception given to the Festival:

- The Exhibition had over 1100 visitors over the two-week period who viewed over 900 entries, with sell out workshops and very well-attended demonstrations
- Eight of the 15 ticketed performances sold out and others were almost at capacity
- Attendance at the free concerts was very good

As in 2022, the main venues used were St Laurence's Parish Church, the Parish Centre, St Lawrence's Primary School, the Silvester Horne Institute (SHI), and Concord College. These venues generally worked very well.

The Committee and lead people for various activities worked very hard to arrange the events held in the evening at the SHI. A new requirement introduced by Church Stretton Town Council was for a Personal Licence Holder to be present for the sale of alcohol at that

venue. The Committee is immensely grateful to Ray Philpotts who took on this role which he also performs for the Stretton Players. The Committee was pleased to meet 50% of the costs of the necessary training and certification for this role.

The audience numbers at the SHI had to be capped at lower levels than hitherto. A late decision by Church Stretton Town Council caused by new fire evacuation arrangements and banning use of the balcony area by audiences, led to rapid changes to event arrangements. Again, the Festival teams worked really hard to deal with this in a constructive manner.

The Festival had a presence at two community events in Spring 2023 – Strettfest and the Fun Day. On both occasions this was an awareness-raising exercise although some tickets sales were made.

The relationship with St Lawrence's Primary School has developed into a longer-term arrangement which will bring mutual benefits – a continuing home for the Exhibition at the School and in 2023 joint promotion of school pupils' artwork through the Festival Exhibition including this year a colouring competition which attracted 30 entries. Also in 2023, the Committee was pleased to support "Arts Award Discover" which enabled all Year 2 pupils at the School to enter for this award and receive a certificate which among other things begins their accumulation of UCAS points. The School and the charity have also arranged joint storage facilities at the School site which is of long-term benefit to both parties.

Structure, governance and management

The Festival is governed and managed by a Committee who are volunteers. The Committee draws on the huge experience, enthusiasm and commitment of more than 70 volunteers who tirelessly come together to demonstrate that the Festival is an event run by the community for the community.

The Charity has no employees or any contractors. No payments other than travel and incidental costs incurred by trustees were made to the trustees.

The trustees are immensely well supported by Graham Cossins who as Website and Technical Lead brings invaluable advice, guidance and input to the Committee's discussions.

During the year, the Committee completed a programme to review and update all of its documentation and policies adding some new policies, notably as regards safeguarding.

The Committee as always carried out a review of the Festival to gather learning points both positive and negative and reviewed various risks.

The Committee wishes to record its very warm thanks to all those who have contributed to the Festival in any way including the members of the Festival – without such support and commitment, the Festival simply would not happen.

The Committee has accepted the resignation of two trustees – Joan Arnfield with effect from 13 August 2023 and Sandra Whitlock with effect from 31 August 2023. Their hard work, sage advice and enthusiastic contribution will be sorely missed. With the loss of these two key individuals along with others stepping back from key roles, the Committee will review the risks and capacity to deliver Festivals in 2024 and beyond. The Committee is very well aware that it relies on the huge input, enthusiasm and skill of a few key people. This remains a continuing risk and the Committee will continue to address this in various ways.

The Committee recruits trustees and others by means of advertising in the local “Stretton Focus”, developing interest among volunteers and members and seeking expressions of interest at Festival events and promotional opportunities.

Financial review

The Charities Acts require the Trustees to prepare financial statements for each financial year which give a true and fair view of the state of affairs of the charity as at the end of the financial year and of the surplus or deficit of the charity. In preparing those financial statements the Trustees are required to:

- select suitable accounting policies and apply them consistently;
- make judgements and estimates that are reasonable and prudent; and
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charity will continue in business;
- state whether applicable accounting standards and statements of recommended practice have been followed, subject to any material change.

The Trustees are also responsible for maintaining adequate accounting records which disclose with reasonable accuracy at any time the financial position of the charity and which are sufficient to show and explain the charity's transactions and enable them to ensure that the financial statements comply with the Charities Acts. They are also responsible for safeguarding the assets of the charity and for taking reasonable steps for the prevention and detection of fraud and other irregularities. During the year, the Committee approved a formal reserves policy and aims to maintain reserves at the agreed level of £40,000. That level will be reviewed annually.

The charity achieved a net surplus on the year of £638. A small working surplus is essential as the Festival has to meet some costs upfront each year ahead of generating any income. The charity's reserves stand at £44,900 compared to £44,200 at the end of 2021-22 financial year.

These results are very rewarding given the reduced income from some ticketed events held at the SHI; the lower cap on numbers almost certainly led to reduced ticket sales given the demand experienced and the ticket “waiting lists” that had to be managed. The Committee estimates the total loss of income at about £2,000. During the year, the charity acquired a storage facility to amalgamate and store securely equipment and materials previously held at Committee members' homes. This was a one-off outlay of slightly under £3,500.

There was excellent work in generating sponsorship from local businesses and individuals. "The objects of the festival shall be to promote, improve, develop and maintain public education in the furtherance of the following objects: appreciation of the arts and sciences of music, opera, ballet, drama, film, literature, painting, drawing, photography and sculpture in all their aspects by the presentation of public concerts, performances, arts exhibitions and in such other ways as the festival Committee shall from time to time determine."

Aims of the Arts Festival

1. To hold a festival in and around Church Stretton run by volunteers with a core of major high-quality events to include concerts, drama, talks, arts, crafts, photography, workshops and other creative and artistic endeavours.
2. To retain a core offer while annually having some experimentation such as new types of art, event or performer so that the Festival –
 - remains vibrant and interesting;
 - adapts to changing tastes; and
 - provides a continuing attractive offering for regular and first-time attendees.

Activities – 2021-22

The Trustees are delighted that it was possible to hold a full Festival in 2022 for the first time since 2019. Like so many arts bodies, the Festival had to suspend all its activities with the onset of the Covid-19 pandemic in 2020. Due to a great deal of hard work by a few core individuals, the Committee held three outdoor events in the summer of 2021 supported by a number of free morning concerts, but no indoor evening concerts and no art exhibition.

On emerging from the pandemic, the Committee faced a number of challenges:

- the loss from the Committee of some key individuals and other volunteers who had been central to the delivery of previous Festivals;
- the unavailability of one of the major venues which had hosted Festival events and the art exhibition for many years, namely, Church Stretton School; and
- a very uncertain environment for the resumption of a major festival including public readiness to return to busy events following the pandemic and an impaired economic situation.

Despite this, the Committee decided to proceed and through very hard work and in some cases, overwork, falling on some key individuals, the Festival was held from 23 July to 13 August 2022 comprising 12 paid-for events, six free coffee concerts, three free organ recitals and an Art Exhibition lasting for two weeks, including three workshops. One event had to be cancelled as the speaker for a talk contracted Covid-19.

The Exhibition moved to a new venue at the Primary School, the main performances were split between St Laurence's Church and the Silvester Horne Institute with one planned for the Parish Centre. The final concert – held one week after the end of the main programme of events - was held at Concord College in Acton Burnell. The coffee concerts continued to be held in St Laurence's as was one organ recital with two further recitals being held in other local churches.

Achievements and performance

The Committee was very pleased with the reception given to the Festival. There was almost universal praise for the new venue for the Exhibition which attendees found to be intimate and engaging. Both the Committee and attendees felt that the quality of exhibits was really high.

The use of the Silvester Horne Institute for the first time was successful alongside the established use of St Laurence's Church. There was very positive feedback for the wide range of performances on offer which included the well-known poet, Roger McGough, dramas about Virginia Woolf and Mary Anning and concerts featuring higher voices and a harp, a brass quartet, a solo pianist and a *Police* tribute band, The Rozzers.

Given the slightly reduced capacity overall of the venues used compared to earlier years, attendances were very good. Ticket sales in advance were strong with most sales being made using the Ticket Source online booking facility. It was clear that once the word spread about the resumption of the Festival and the high quality of what was on offer, tickets continued to be sold - in many instances right up until the night of performance. The Rozzers concert and the Roger McGough poetry recital were entirely sold out in advance.

The footfall for the Exhibition was slightly lower than in some earlier years but the volume of sales was the highest ever.

There was excellent work in generating sponsorship from local and some other businesses and sources and the Committee wishes to thank the following who were Festival sponsors: Mr Francis and Mrs Alison Acton, Mrs Meryl Austin, Belvedere Guest House, Burway Books, Continental Fireplaces, Entertaining Elephants, Mr Howard Franklin, Dr Albert Gallon, Jemima's Kitchen, Peter Jenison Memorial Trust, Matthew Mills Graphic Design, Morris Care, PCB Solicitors, Ragleth Gallery, Ragleth Inn, Peppers, September Books, Mr Alan and Mrs Elaine Stockbridge, Stretton Livestock Husbandry, Tanners Wines, Wrights Estate Agents, Victoria House Bed and Breakfast. - make judgements and estimates that are reasonable and prudent: and
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charity will continue in business;
- state whether applicable accounting standards and statements of recommended practice have been followed, subject to any material change.

The Trustees are also responsible for maintaining adequate accounting records which disclose with reasonable accuracy at any time the financial position of the charity and which are sufficient to show and explain the charity's transactions and enable them to ensure that the financial statements comply with the Charities Acts. They are also responsible for safeguarding the assets of the charity and for taking reasonable steps for the prevention and detection of fraud and other irregularities.

The Committee was very pleased to achieve a net surplus on the year of £4251.43. A small working surplus is essential as the Festival has to meet some costs upfront each year ahead of generating any income. This outturn has led to the reserves for the Festival standing at £44,225.32 compared to £39,973.89 at the end of 2020-21 financial year.

While the Festival benefits from strong sponsorship locally, it does not rely on any grant income either locally or nationally.

This report was approved by the Trustees on 25 October 2022.

Independent Examination

The Trustees have opted to have an Independent Examination by a suitably qualified Chartered Accountant. The Independent Examiner appointed by the trustees is Ruth Whiting of RLW Accountants whose report together with the accounts for 2021-22.

As the charity trustees of the Trust, you are responsible for the preparation of the accounts in accordance with the requirements of the Charities Act 2011 ("the Act").


