Objects: THE ADVANCEMENT OF ANY ONE OR MORE OF THE FOLLOWING OBJECTS AND IN SUCH MANNER AS THE TRUSTEES SHALL IN THEIR ABSOLUTE AND UNCONTROLLED DISCRETION FROM TIME TO TIME DETERMINE NAMELY:- (A) THE ADMINISTRATION OF ANY PROPERTY OR ESTATE USED OR INTENDED FOR ANY RELIGIOUS OR OTHER CHARITABLE INSTITUTION OR WORK WHICH SHALL BE ESTABLISHED OR MAINTAINED FOR ANY OF THE FOLLOWING PURPOSES:- (I) FOR THE FURTHERANCE OF RELIGIOUS OR SECULAR EDUCATION; (II) THE ADVANCEMENT OF THE PROTESTANT AND EVANGELICAL TENETS OF THE CHRISTIAN FAITH EITHER IN THE UNITED KINGDOM OR OVERSEAS; (III) THE ENCOURAGEMENT OF MISSIONARY ACTIVITY DESIGNED FOR THE SPREAD OF SUCH CHRISTIAN FAITH; (IV) THE RELIEF OF THE POOR AND NEEDY IN THE UNITED KINGDOM OR ABROAD; (V) THE HELP AND COMFORT OF THE SICK AND AGED. (C) GENERALLY FOR THE ADVANCEMENT OF ANY RELIGIOUS OR OTHER CHARITABLE OBJECT NOT INCONSISTENT WITH THE FOREGOING WHICH MAY FROM TIME TO TIME COMMEND ITSELF TO THE TRUSTEES.

Activities: Provision of Cristian resources for education, worship , and personal use.Listening ear for those in distress. Help with form-filling for those with learning difficulties. Voluntary employment work placements for variety of situations. Quiet space for people to sit, pray, think in peace. Prayer requests. Open forum for discussions of faith. Talks & presentations for community groups.
