Summary of the main achievements of the charity during the year

The charity was able to continue to raise funds through the school lottery activity, Justgiving donations and school fundraising activities.

Incoming resources for the year ended 31 August 2024 totalled £61,798 (2023: £4,800).

Most of the funds are raised through donations and fundraising. These funds raised support and contribute towards the expenditure requirements of the charity.

Resources expended for the year ended 31 August 2024 totalled £2,438 (2023: £2,958).

The net result for the year was an in-year surplus of £59,360 (2023: £1,842).

Retained funds carried forward at 31 August 2024 are £80,877 (2023: £21,517).

The trustees continue to monitor the activities and budgets of the charity. The trustees are of the opinion that the necessary measures have been implemented to ensure the viability of the charitable trust over the medium term.

Brief statement of the charity's policy on reserves

It is the policy of the charity that unrestricted funds which have not been designated for a specific use should be maintained at a level equivalent to between three and six month's expenditure. The trustees considers that reserves at this level will ensure that, in the event of a significant drop in funding, they will be able to continue the charity's current activities while consideration is given to ways in which additional funds may be raised. This level of reserves has been maintained throughout the year.



