Report of the Trustees for the Year Ended 31 March 2025

The trustees present their report with the financial statements of the charity for the year ended 31 March 2025. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019).

OBJECTIVES AND ACTIVITIES

Objectives and aims

The Purpose of Scouting

Scouting exists to actively engage and support young people in their personal development, empowering them to make a positive contribution to society.

The Values of Scouting

As Scouts we are guided by these values:

Integrity - We act with integrity; we are honest, trustworthy and loyal.

Respect - We have self-respect and respect for others.

Care - We support others and take care of the world in which we live.

Belief - We explore our faiths, beliefs and attitudes.

Co-operation - We make a positive difference; we co-operate with others and make friends.

The Scout Method

Scouting takes place when young people, in partnership with adults, work together based on the values of Scouting and:

- enjoy what they are doing and have fun
- take part in activities indoors and outdoors
- learn by doing
- share in spiritual reflection
- take responsibility and make choices
- undertake new and challenging activities
- make and live by their Promise.

Significant activities

We deliver a balanced programme of skills for life, to young people aged 4 to 14, contributing to delivering the vision, mission and values of the Scout Association <https://www.scouts.org.uk/about-us/strategy>

Group/ section numbers are dependent upon the age of the children & young people, and the numbers of volunteer leaders we have.

Any child or young person who wishes to attend our group (and a place is available), is welcomed, and the leaders make every effort to meet the needs of each individual.

Public benefit statement

105th Sheffield (High Green) Scout Group, 'The Group' meets the Charity Commission's public benefit criteria under both the advancement of education and the advancement of citizenship or community development headings.

Grantmaking

The majority of grantmaking activity throughout the period was a lot of work and time spent applying for the YIF pre-construction & building grant. However this was successful as the Building work commenced in August 2023 and was completed in June 2024. Final payments of the grant are due to be made in the following few months from the issue of the financial statements.

OBJECTIVES AND ACTIVITIES

Volunteers

Volunteers are crucial to the day to day running and success of the Scout Group. They provide numerous services and operations within the Scout Group such as:

- Organising, assisting and supervising events and activities off-site such as camps.
- Assist with fundraising activities & events, and assist with marquee & equipment hire at various venues around the county.
- In particular, this year, volunteers have assisted with the move between buildings packing up the old building and setting up the new HQ and going forward they will be key in helping with maintenance of the new building.
- Cleaning and gardening within the local community.

Volunteer leaders run each section and are responsible for delivering inspiring programmes and activities. The Team Leader from each section is also a member of the Trustee board. They report to the Trustees, who are responsible for governance and overall running of the group.

Volunteers also assist with the application for grants and funding. They also assist with raising awareness of the Scout Group through methods such as social media communications and press articles etc.

Communication is also a key benefit of the use of volunteers within the Scout Group as they frequently liaise with local community leaders & councillors also liaising with the Scout Association on a wider scale at national, county and district levels.

ACHIEVEMENT AND PERFORMANCE

Fundraising activities

Leaders and young people ran a fundraising BBQ & stall at a local community event in the park.

With the completion of the new HQ building, a fundraising Band & BBQ event was held on the newly completed premises, enjoyed by the local community.

FINANCIAL REVIEW

Financial Activity

Income raised through donations, subscriptions and gift aid was £19,629 (2024: £17,850). The main generator of these funds being subscriptions to the scouts/fees paid by members.

Income raised through other fund raising activities such as camps & events, hire of equipment etc was £14,003 (2024: £12,813).

Grant income received for the year was £522,669 (2024: £1,201,010), grant income remains abnormally high this year due to the YIF grant awarded towards our Building Development Project.

Total expenditure during the year was £37,938 (2024: £32,738).

FINANCIAL REVIEW

Investment policy and objectives

The Group's Income and Expenditure is small and under normal circumstances does not have sufficient funds to invest in longer term investments such as stocks and shares. The Group has therefore adopted a low risk strategy to the investment of its funds. All funds are held in cash using only mainstream banks or building societies or the Sheffield Scout Resources Charity savings fund.

The Group Trustee Board regularly monitors the levels of bank balances and the interest rates received to ensure the group obtains maximum value and income from its banking arrangements. Occasionally this may involve using an account that requires a period of notice before funds may be withdrawn, before doing so the Group Trustee Board considers the cash flow requirements.

Reserves policy

The Group's policy on reserves is to hold sufficient resources to continue the charitable activities of the group should income and fundraising activities fall short. The Group Trustee Board considers that the group should hold a sum equivalent to 6 months running costs, circa £20,000. This figure will be reviewed once we have completed our first year in the new building.

The Group held free reserves of £58,674 against this at year end. This is above the level required for operating expenses. However this can be explained by a major Building Development Project to replace our headquarters building, and equip it.

CURRENT RESERVES:

The group Trustee Board considers that the group should hold reserves equivalent to:

- i. £20,000 6 months' running costs.
- ii. £10,000 emergency fund to carry out repairs, or replace equipment.
- iii. £20,000 future development of the site.

FUTURE PLANS

Several volunteer leaders have been recruited allowing the Cub & Squirrel sections to expand, offering more places to young people. We are working towards expanding the Beaver and Scout sections too.

With completion of the new HQ building works, Community use of the new building has increased over the last year.

We have a Group Camp planned for September 2025, and planning is underway to celebrate our 100th Anniversary in 2026.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing document

The Group's governing documents are those of the The Scout Association. They consist of a Royal Charter, which in turn gives authority to the Bye Laws of the Association and The Policy, Organisation and Rules of The Scout Association.

Charity constitution

The Group is a trust established under its rules which are common to all Scouts.

Recruitment and appointment of new trustees

The Trustees are appointed in accordance with the Policy, Organisation and Rules of The Scout Association.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Organisational structure

The Group is managed by the Group Trustee Board, the members of which are the 'Charity Trustees' of the Scout Group which is an educational charity. As charity trustees they are responsible for complying with legislation applicable to charities. This includes the registration, keeping proper accounts and making returns to the Charity Commission as appropriate.

The Trustee Board consists of the Chair, Treasurer and 7 Trustees and meets every 3 months.

Members of the Trustee Board complete 'Being a Scouts Trustee' learning within the first 6 months of joining the Board.

This Group Trustee Board exists to make sure the charity is well managed, risks are assessed and mitigated, buildings and equipment are in good working order, and everyone follows legal requirements and the organisation's policies and rules. Their support helps other volunteers run high-quality and safe programmes that give young people skills for life.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Risk and Internal Control

The Group Trustee Board has identified the major risks to which they believe the Group is exposed, these have been reviewed and systems have been established to mitigate against them. The main areas of concern that have been identified are:

i. Damage to the building, property and equipment. The Group would request the use of buildings, property and equipment from neighbouring organisations such as the church, community centres, and other Scout Groups. Similar reciprocal arrangements exist with these organisations. The Group has sufficient buildings and contents insurance in place to mitigate against permanent loss.

ii. Injury to leaders, helpers, supporters and members. The Group through the capitation fees contributes to the Scout Associations national accident insurance policy. Risk Assessments are undertaken before all activities. The Group has Public Liability Insurance through the Scout association, and also pays for a 'Scout Personal Accident & Medical Expenses Insurance Policy, for Helpers/Supporters and non-member children'

iii. Reduced income from fundraising. The Group is primarily reliant upon income from subscriptions and fundraising. The group does hold a reserve to ensure the continuity of activities should there be a major reduction in income. The Board could raise the value of subscriptions to increase the income to the group on an ongoing basis, either temporarily or permanently.

iv. Reduction or loss of leaders. The group is totally reliant upon volunteers to run and administer the activities of the group. If there was a reduction in the number of leaders to an unacceptable level in a particular section, or the group as a whole, then there would have to be a contraction, consolidation, or closure of a section. In the worst case scenario the complete closure of the Group.

v. Reduction or loss of members. The Group provides activities for all young people aged 4 to 18. If there was a reduction in membership in a particular section, or the group as whole, then there would have to be a contraction, consolidation, or closure of a section. In the worst case scenario the complete closure of the Group



1. ACCOUNTING POLICIES

Basis of preparing the financial statements

The financial statements of the charity, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Charities Act 2011. The financial statements have been prepared under the historical cost convention.

Income

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

Expenditure

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

Tangible fixed assets

Depreciation is provided at the following annual rates in order to write off each asset over its estimated useful life.

Computer equipment - 20% on reducing balance

No depreciation was charged on freehold property during the year as the building was still under construction.

Assets costing more than £1,000 are capitalised in the period that they are received.

Taxation

The charity is exempt from tax on its charitable activities.

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

Further explanation of the nature and purpose of each fund is included in the notes to the financial statements.

Hire purchase and leasing commitments

Rentals paid under operating leases are charged to the Statement of Financial Activities on a straight line basis over the period of the lease.

The trustees present their report with the financial statements of the charity for the year ended 31 March 2024. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019).

OBJECTIVES AND ACTIVITIES

Objectives and aims

The majority of grantmaking activity throughout the period was a lot of work and time spent applying for the YIF pre-construction & building grant. However this was successful as the Building work commenced in August 2023 and was completed in June 2024. Final payments of the grant are due to be made before the end of the current financial year.

OBJECTIVES AND ACTIVITIES

Volunteers

Volunteers are crucial to the day to day running and success of the Scout Group. They provide numerous services and operations within the Scout Group such as:

- Organising, assisting and supervising events and activities off-site such as camps.
- Assist with fundraising activities & events, and assist with marquee & equipment hire at various venues around the county.
- In particular, this year, volunteers have assisted with the move between buildings packing up the old building and setting up the new HQ and going forward they will be key in helping with maintenance of the new building.
- Cleaning and gardening within the local community.

Volunteer leaders run each section and are responsible for delivering inspiring programmes and activities. The Team Leader from each section is also a member of the Trustee board. They report to the Trustees, who are responsible for governance and overall running of the group.

Volunteers also assist with the application for grants and funding. They also assist with raising awareness of the Scout Group through methods such as social media communications and press articles etc.

Communication is also a key benefit of the use of volunteers within the Scout Group as they frequently liaise with local community leaders & councillors also liaising with the Scout Association on a wider scale at national, county and district levels.

ACHIEVEMENT AND PERFORMANCE

Fundraising activities

During the period a full programme of fundraising events was not possible to carry out, due to not having access to a building, while the new HQ building was under construction.

However where possible events were carried out that did not require use of such buildings. Leaders and young people took part in a sponsored walk and camp-out during the period and they also ran a BBQ stall at a local community event in the park.

FINANCIAL REVIEW

Financial Activity

Income raised through donations, subscriptions and gift aid was £17,850 (2023: £15,316). The main generator of these funds being subscriptions to the scouts/fees paid by members.

Income raised through other fund raising activities such as camps & events, hire of the building and equipment etc was £12,813 (2023: £23,173).

Grant income received for the year was £1,201,010 (2023: £52,306), this year has seen a drastic one-off increase due to the YIF grant awarded towards our Building Development Project.

Total expenditure during the year was £32,738 (2023: £30,184).

FINANCIAL REVIEW

Investment policy and objectives

The Group's Income and Expenditure is small and under normal circumstances does not have sufficient funds to invest in longer term investments such as stocks and shares. The Group has therefore adopted a low risk strategy to the investment of its funds. All funds are held in cash using only mainstream banks or building societies or the Sheffield Scout Resources Charity savings fund.

The Group Trustee Board regularly monitors the levels of bank balances and the interest rates received to ensure the group obtains maximum value and income from its banking arrangements. Occasionally this may involve using an account that requires a period of notice before funds may be withdrawn, before doing so the Group Trustee Board considers the cash flow requirements.

Reserves policy

The Group's policy on reserves is to hold sufficient resources to continue the charitable activities of the group should income and fundraising activities fall short. The Group Trustee Board considers that the group should hold a sum equivalent to 6 months running costs, circa £20,000. This figure will be reviewed once we have completed our first year in the new building.

The Group held free reserves of £58,674 against this at year end. This is above the level required for operating expenses. However this can be explained by a major Building Development Project to replace our headquarters building, and equip it.

CURRENT RESERVES:

The group Trustee Board considers that the group should hold reserves equivalent to:

- i. £20,000 6 months' running costs.
- ii. £10,000 emergency fund to carry out repairs, or replace equipment.
- iii. £40,452 final payment for Building Development Project.
- iv. £20,000 future development of the site.

FUTURE PLANS

In the forthcoming period there will be a recruitment drive for new volunteer leaders, who once inducted & trained will allow each section to expand and possibly split into two evenings. This will enable the group to offer significantly more places for young people and reduce the number on our waiting lists.

Also with the new building construction now fully complete we will now be able to increase community use of the new building allowing us to undertake more fundraising activities and events within the period.

Governing document

The Group's governing documents are those of the The Scout Association. They consist of a Royal Charter, which in turn gives authority to the Bye Laws of the Association and The Policy, Organisation and Rules of The Scout Association.

Charity constitution

The Group is a trust established under its rules which are common to all Scouts.

Recruitment and appointment of new trustees

The Trustees are appointed in accordance with the Policy, Organisation and Rules of The Scout Association.

Organisational structure

The Group is managed by the Group Trustee Board, the members of which are the 'Charity Trustees' of the Scout Group which is an educational charity. As charity trustees they are responsible for complying with legislation applicable to charities. This includes the registration, keeping proper accounts and making returns to the Charity Commission as appropriate.

The Trustee Board consists of the Chair, Treasurer and 7 Trustees and meets every 3 months.

Members of the Trustee Board complete 'Being a Scouts Trustee' learning within the first 6 months of joining the Board.

This Group Trustee Board exists to make sure the charity is well managed, risks are assessed and mitigated, buildings and equipment are in good working order, and everyone follows legal requirements and the organisation's policies and rules. Their support helps other volunteers run high-quality and safe programmes that give young people skills for life.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Risk and Internal Control

The Group Trustee Board has identified the major risks to which they believe the Group is exposed, these have been reviewed and systems have been established to mitigate against them. The main areas of concern that have been identified are:

- i. Damage to the building, property and equipment. The Group would request the use of buildings, property and equipment from neighbouring organisations such as the church, community centres, and other Scout Groups. Similar reciprocal arrangements exist with these organisations. The Group has sufficient buildings and contents insurance in place to mitigate against permanent loss.
- ii. Injury to leaders, helpers, supporters and members. The Group through the capitation fees contributes to the Scout Associations national accident insurance policy. Risk Assessments are undertaken before all activities. The Group has Public Liability Insurance through the Scout association, and also pays for a 'Scout Personal Accident & Medical Expenses Insurance Policy, for Helpers/Supporters and non-member children'
- iii. Reduced income from fundraising. The Group is primarily reliant upon income from subscriptions and fundraising. The group does hold a reserve to ensure the continuity of activities should there be a major reduction in income. The Board could raise the value of subscriptions to increase the income to the group on an ongoing basis, either temporarily or permanently.
- iv. Reduction or loss of leaders. The group is totally reliant upon volunteers to run and administer the activities of the group. If there was a reduction in the number of leaders to an unacceptable level in a particular section, or the group as a whole, then there would have to be a contraction, consolidation, or closure of a section. In the worst case scenario the complete closure of the Group.
- v. Reduction or loss of members. The Group provides activities for all young people aged 4 to 18. If there was a reduction in membership in a particular section, or the group as whole, then there would have to be a contraction, consolidation, or closure of a section. In the worst case scenario the complete closure of the Group

1. ACCOUNTING POLICIES

Basis of preparing the financial statements

The financial statements of the charity, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Charities Act 2011. The financial statements have been prepared under the historical cost convention.

Income

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

Expenditure

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

Tangible fixed assets

Depreciation is provided at the following annual rates in order to write off each asset over its estimated useful life.

Computer equipment - 20% on reducing balance

No depreciation was charged on freehold property during the year as the building was still under construction.

Assets costing more than £1,000 are capitalised in the period that they are received.

Taxation

The charity is exempt from tax on its charitable activities.

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

Further explanation of the nature and purpose of each fund is included in the notes to the financial statements.

Hire purchase and leasing commitments

Rentals paid under operating leases are charged to the Statement of Financial Activities on a straight line basis over the period of the lease.

Chairperson's Report

We are pleased to welcome you all to our 2023 Annual General Meeting. We have had a full year of face-to-face Scouting and we are delighted that the Group has survived the Covid 19 pandemic years of disruption, and has gone from strength to strength.

In October 2022 we were delighted to be in a position to start a Squirrels Section, one of only two in Don District and a limited number across the Country. Laura Simpson joined us as Squirrels Leader and has built a fantastic group of volunteer leaders, three of whom support the Squirrel's Section and three leaders who support another Section as well! We have 13 Squirrels on roll and a waiting list, this is an amazing achievement to start a new Section from scratch and testament to the volunteer leaders who have stepped up or joined us new – thank you.

We have record numbers in all our Sections; 27 Scouts, 40 Cubs with 4 on a waiting list, 20 Beavers with 7 on the waiting list, with the addition of the new Squirrels Section this has taken our numbers on roll over the 100 mark for the first time in the groups 98 year history!

All the Sections have thoroughly enjoyed getting out and about again and the Group has organised numerous outings and camps and the Sections have all participated in District events.

Many of you will not be aware that for many, many, many years the Group Executive has been looking for opportunities to replace the building we are sat in today. There have been numerous fund-raising activities over the years which have contributed to the Hut replacement fund but as you can imagine this was a big ask given the costs associated with this sort of project and we found it impossible to reach our goal internally.

Over the years we have explored different external funding pots, none of which have come to anything, until August 2022 when a fund entitled the Youth Investment Fund – a Department for Digital Culture, Media and Sport Funded grant scheme was released. We identified this has an opportunity which we felt we would fit the criteria and the work began to apply for funding!

We have progressed through the different stages but this did mean that we have had to expend a considerable amount of our own funding to engage different professional bodies to fulfil the application stages. In January 2023, at very short notice and with a very quick turn round we were asked to apply for a Pre-Construction Grant and we were absolutely delighted to receive over £50,000 to contribute to the associated costs. It was made clear that this grant did not mean we would get the full grant.

As you will be aware we have a planning application with Sheffield City Council for a design which we think will meet the needs of Scouting in High Green for many years to come. We are now waiting for news of the Grant application.

I do hope you enjoy reading the booklet and again delighted to see you all here tonight. This just leaves me to say, thank you again for your support of your young people and 105th Sheffield (High Green) Scout Group.

We are delighted to welcome you all to our first post pandemic, in person, Annual General Meeting. It seems a long, long time since we were able to meet altogether to celebrate another successful year of Scouting at 105th (Sheffield) High Green Scout Group. Please take away the booklet which you were handed when you came tonight or received electronically in your email inbox and recap on the past year.

It is a well said statement that it has been an extra ordinary 2 years in all our life time, whether you are a young beaver, cub or scout, a leader, a parent/carer or Executive Committee member. We have all had to learn to adapt to a life with a covid pandemic in varying degrees. Obviously, Scouting was impacted by the restrictions which were correctly implemented but it never stopped, it continued in different formats, but it never stopped and this was testimony to everyone who believed in the important role it plays in young people's lives

I would therefore like to take this opportunity to personally thank all leaders, helpers, volunteers and fellow Executive Committee members for all their hard work and dedication to serving our young people throughout the past year. But I would also like to thank you all who supported your young people to continue to benefit from Scouting in High Green, whilst you were all adapting your working and family lives, we appreciate this wasn't easy for any of you.

So onwards and upwards, I know the leaders have been so excited at the prospect of resuming face to face meetings and have thrown themselves behind developing a programme of both internal and external activities. Many of your young people will be benefitting from this programme and the presentation which follows the formal part of this meeting is testament to both leaders and young people who have worked so hard to achieve their badges.

The postponement of face-to-face meetings presented some issues regarding the financial sustainability of the group and we are very grateful to all the parents who saw value in the group and offered to pay or part pay their young people's subs during the lockdown. Whilst we really appreciate this gesture, we also understand this was not possible for all families – thank you all.

The Group was very fortunate to be in receipt of some Business Grants which put us in a strong position to move forward, as always, the young people who meet at the Hut are always at the forefront of any plans and as a thank you to everyone who stuck with us the Executive Committee took the first opportunity it could to fund the Group Camp in September 2021 and we hope that everyone who attended had a great time.

We currently have 24 Beavers, 21 cubs and 28 Scouts, totalling 73 young people on role across the three sections and 27 Beavers (15 at age, 12 under age), 5 Cubs and 3 Scouts waiting to join. Our challenge is always about ensuring we have the correct number of leaders and helpers to manage the groups on a weekly basis and our waiting lists post pandemic are longer than ever and if you, or you know of anyone who would like to volunteer, please do not hesitate to contact your young person's leader or any of the Executive Committee.

One of the benefits of our post pandemic community is that we have more individuals and groups wanting to hire our hall for birthday parties etc which is a fantastic revenue stream for the group and all helps towards our ultimate goal of replacing the hut with a more sustainable building for the future but it means that we need to hire a permanent cleaner for the building, this is a flexible role and if anyone would like more information please see me this evening.

Due to the continuing uncertainty in the number of people able to meet inside and having hosted last year's Annual General Meeting as a successful online event we have decided to continue this format for 2021. Please read the booklet which has been sent out to you electronically.
