(B) TO ESTABLISH OR TO SECURE THE ESTABLISHMENT OF A COMMUNITY CENTRE AND TO MAINTAIN AND MANAGE OR TO CO-OPERATE WITH ANY LOCAL AUTHORITY IN THE MAINTENANCE AND MANAGEMENT OF SUCH A CENTRE FOR ACTIVITIES PROMOTED BY THE ASSOCIATION AND ITS CONSTITUENT BODIES IN FURTHERANCE OF THE ABOVE OBJECTS (C) TO PROMOTE SUCH OTHER CHARITABLE PURPOSE OR PURPOSES WITHIN THE AREA OF BENEFIT AS THE COMMITTEE SHALL FROM TIME TO TIME DETERMINE
