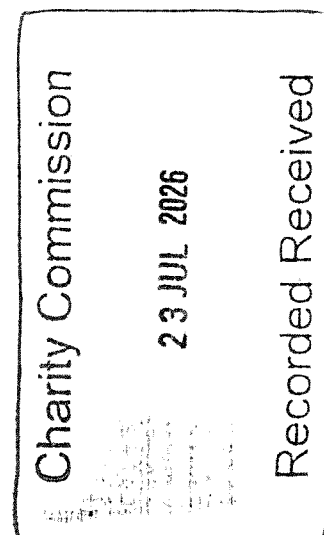

The bankers of the charity continue to be Bank of Scotland, Cardiff CF10 3YB.

In the opinion of the trustees the state of the charity's finances is satisfactory and funds are available for all necessary expenditure.

The trustees have assessed all the risks to which the charity may be exposed and have systems to cope with any eventuality. To this end the trustees are gifting the charity building known as "Oasis" to the Vineyard Church Cardiff. The new entity will become Blackwood Vineyard Church where the congregations will merge and continue the work as set out below.

Objectives and activities

The core objects of the charity continue to be

- a. The advancement of the Christian faith
- b. The relief of persons who are in conditions of need, hardship or distress
- c. The advancement of education on the basis of Christian principles

This has been accomplished during the year by the following:

- A. Disbursing funds to relief aid globally and nationally and increasingly by meeting needs of individuals in our locality
- B. Continuing to help the homeless and individuals with life controlling problems
- C. Using a variety of evangelism tools wherever possible.

Achievements and Performance

We have continued to support organisations which support and assist people with addiction problems. We are able to help addicted people in our area through our contacts in these organisations.

We support front line workers in Afghanistan, Myanmar and other crisis areas.

The Trussell Trust has continued to distribute food parcels from the foodbank held on our premises to meet the desperate needs in our area. This is often achieved by taking parcels by road to those in need.

We continue to provide a safe and welcoming environment for those wishing to join us with fully equipped rooms for children of all ages.
