The Trustees present their report and financial statements for the year ended 30 September 2024.

Status

The organisation became a registered charity - registration number 517092 on 8 January 1986 having been formed on 20 November 1985.

It is governed by a constitution adopted on 20 November 1985 and amended in November 1988, November 2000, September 2001, November 2002 and December 2012.

Report of the Trustees for the year ended 30 September 2024

Structure, Governance and Management

The Trustees present their report along with the financial statements of the Charity for the year ended 30 September 2024. The financial statements have been prepared in accordance with the accounting policies set out on page 9 and comply with the aims of the Charity and applicable law.

Appointment of Trustees

New Trustees are nominated by the Management Committee and Trustees at the AGM, and are eligible for re-election annually.

The Chairman is only allowed to remain in office for three consecutive years.

Objectives and Activities

To promote for the benefit of the public the study and research of any aspect of archaeology or history relating to the former county of Worcestershire and the surrounding area.

The Chairman's Report gives details of the activities undertaken during the year.

Public Benefit

The Trustees have complied with their duty as required by the Charities Act 2011 to have due regard to the guidance issued by the Charity Commission concerning public benefit requirement.

How the charity has provided public benefit through lectures, excursions etc is outlined in the Chairman's Report.

Financial Review

The net receipts for the year were £1,287. Cash funds at 30 September 2024 were £93,097.

Excursions Account

The excursions account is separate from the Main Account.

The financial target for the Excursions programme is to at least cover all costs. Accumulated surpluses, though remaining within the Society's main accounts, are 'ring fenced' for use in small capital projects improving the services of the Society, e.g. for its Library.

Reserves

The Trustees have agreed that the Society's Reserves should always be sufficient to cover one year's running expenses plus the cost of producing two editions of the Transactions. This is assessed to be £15,000 at the present time.

Chairman's Report

The Society continues to fulfil its stated charitable aims through a wide range of activities including winter lectures, summer excursions, publications, the management of its collections, and advocacy for the conservation of and research into the heritage of Worcestershire.

Membership

The Society had 202 members at the end of September 2024. The Society will take opportunities to increase membership as they arise, for example by continuing to support community projects which brings the work of the Society to a wider audience and manning a stand at conferences and other events.

Lectures

The lecture programme took place through a combination of face-to-face meetings at the Hive, Sawmill Walk, The Butts, Worcester WR1 3PD, and via Zoom video-conferencing during the winter months.

The 2023-2024 lecture season was put together by the Programme Secretary, James Dinn, and ranged widely over the archaeology and history of the county and beyond:

Publications

Dr Shelagh Norton is currently editor of the Society's *Transactions*. Volume 29, which is the centenary edition, was published and distributed in November 2024. Dr Norton has successfully found a new publisher for the *Transactions*, after the previous publishers retired.

Dr Murray Andrews continues to edit the *Recorder* newsletter. He is also editor of the *Festschrift* volume in honour of Robin Whittaker, due out shortly.

Other Matters

The revamped Society website became available in 2023, and the expenses of the website were finalised.

A WAS library subcommittee was formed as a liaison with the HIVE library, and are in the process of developing a plan to make the current WAS collection more available to members.

Money was contributed to WAAS to support an Archaeology Careers insight weekend.

Promotional materials were purchased to accompany committee members to events as possible recruitment tools.

The digitisation of the *Transactions* has been delayed until this year, where costings and a proposal will be developed.

Funding was provided for radiocarbon dates for 'The Body on the Bromyard Line' project, led by Aidan Smythe, Wychavon District Council.

Conclusion

All the Officers and the Committee of the Society continue to undertake their responsibilities with willingness, and to go out of their way to help with promoting and supporting archaeology and local history in Worcestershire. I am very grateful for their support and that of the many members who play an active part in undertaking essential tasks in support of the Society.


