**Activities:** Aberthin Village Hall is of local historic interest, being the second oldest Wesleyan Chapel in Glamorgan. Apart from preserving the fabric of this historic building, it is a centre for Aberthin Village activities with both organised events and private hiring. Amongst others, a children's playgroup meets daily in the Hall, and it is used on 2 Sundays per month for a village religious service.
