AREA OF BENEFIT SHALL MEAN THE PARISHES OF ASKRIGG, AYSGARH, BAINBRIDGE, BELLERBY, BISHOPDALE, BURTON-CUM-WALDEN, CALDBERGH WITH EAST SCRAFTON, CARLTON HIGHDALE, CARLTON TOWN, CAPERBY CUM THORESBY, CASTLE BOLTON WITH EAST AND WEST BOLTON, COVERHAM WITH AGGLETHORPE, EAST WITTON OUT, HARMBY, HAWES, HIGH ABBOTSDALE, LEYBURN, LOW ABBOTSDALE, MELMERBY, MIDDLEHAM, NEWBIGGIN, PRESTON UNDER SCAR, REDMIRE, SPENNITHORNE, THORALBY, THORNTON RUST, WENSLEY, WEST SCRAFTON AND WEST WITTON.
