

I have examined the Accounts and Financial Records of the above Association for the year ended 30th September, 2022.

The records are in good order; prepared Accounts are clear, accurate and in accordance with the Charities Act; and balances and transactions tally with the Bank statements held on file.

An operating loss of £10,500.68 for the year, primarily due to the net expenditure of £14,755 on playground equipment, was offset by a significant £45,651.70 Legacy Donation, increasing total bank balances to £94,323.44 at year end.
