This is the treasurers report for the year April 2020 to March 2021. The year started off with the unit in lock down which with the grants from various sources allowed the staff to carry out a lot of refurbishment of the building. This refurbishment was to allow at later dates that the unit could be used for sea cadet courses to be run when we was able to reopen. The grants received allowed the unit to refit new showers and most important a new fire alarm system.

The unfortunate consequence of the lock down meant we lost a lot around 1/3 of our cadets who did not return after we could reopen this cause a large drop in cadet donations.

The unit as changed suppliers of electricity and gas as per agreements with MSSC Hq and smart meters fitted. We have had various different groups using the unit which has helped with the income of the unit.

The current level of funding is sufficient and we are able to maintain the current levels of spending with on going unit upkeep.
