3. Minutes of the 71st Annual General Meeting

Andrew asked that everyone had picked up their copy of the booklet where the minutes of the last meeting were

displayed. He asked if they had chance to look at the minutes of the 71st AGM and were happy with the contents.

4. Report of the District Chairman

Andrew referred to his report on page 6 of the booklet. Andrew wished to thank all the Leaders and Adults who work in Scouting in this District without you volunteering, we would not exist. Keep up the good work we are doing very well.

We now have a new renter, Acorn Gymnastics who use the building every Monday morning.

6th Cheadle Hulme folded and their monies came into District along with their assets. We used the funds to put a standing down the side of the building, a storage unit is also going to be put down the side for the equipment so that everything is on site. Their assets just covered their capitation for the last 2 years.

It was proposed that the District Capitation fee for next year should just go up by £1 which will mean £50 per head.

NOTES TO THE ACCOUNTS FOR THE YEAR ENDED 31TH MARCH 2022

Contingent Liabilities and Future Obligations

The Scout Council has a 50% share in the running of Abney Scout and Guide Residential Centre. Should the Centre incur losses, the Council may be called upon to contribute towards these losses.

The Scout Council has an obligation for rent payable in the future to Stockport Metropolitan Borough Council of £420 (Four hundred and twenty pounds) per annum, subject to review, for the remainder of the lease i.e., 13 years.

Reserves

The District's policy on general reserves is to hold the following:

- £10,000 to enable it to help Groups in an emergency.
- £5,000 to cover replacement/renewal of Base Camp facilities.
- £10,000 to meet possible development of Base Camp headquarters.
- £10,000 to meet the anticipated costs of the District's future activities.
- £5,000 to contribute to Abney Scout & Guide Centre if losses should be incurred.

£3000 ring-fenced as specified on page three

Property

"Base Camp" is occupied under a 21year lease from the Metropolitan Borough Council of Stockport which commenced on 21st October 2013.

Non-Monetary Assets

These are shown at the lower of Estimated Market Value or Insured Value.

Accounting Policies

1. Welcome by the District Commissioner

Neil welcomed everyone to this 71st Annual General Meeting in the absence of a District Chairman. He thanked everyone for attending on such a wet evening.

2. Apologies for Absence

There were twenty-two attendees present. Apologies were received from Phil Horton and Ben Cottrell.

3. Minutes of the 70th Annual General Meeting

Neil asked that everyone had picked up their copy of the booklet where the minutes of the last meeting which were held over Zoom. He asked if they had chance to look at the minutes of the 70th AGM and were happy with the contents. All were accepted.

4. Election of the District Chairman

Neil has received one nomination for this position which is Mr. Andrew Hughes Mr A Sumner seconded this. Mr Hughes was approved nem con.

5. Report of stand in District Treasurer and Fixing of Subscriptions.

Bob gave an overview of the current financial status which he referred to page 8 of the booklet. Last year base camp was more or less closed due to the pandemic, there were occasional rentals from some outside users when lockdown was eased, we were lucky that the business rates were frozen for the year and we received grants to the value of £19,669 which offset the loss from rentals, which helped us have a surplus at the end of the year. During lockdown the now that of badges purchased were less than usual.

These accounts were prepared by Mr Chris Jeffries who for the last 2½ to 3 years had taken over the accounts and had done a splendid job, Bob formally thanked Mr Jeffries .

Bob then asked if anyone had any questions regarding the accounts, he would be happy to answer them, no questions were forthcoming.

The Accounts were approved as correct nem con.

To help with the groups post pandemic Bob proposed that the District Levy is held at £3.00 per head. He asked for someone to second the motion and Mr Stuart Cox confirmed. Subscriptions were approved nem.con.

Neil felt that the £3.00 was the right thing to do moving forward to help the Groups. He said that this will be reviewed again next year.

6. Report of District Commissioner

Neil referred to his report on page 6 of the booklet. He thanked all leaders and members of the Cheadle District who had kept scouting going over the last 12-18 months. The contents of this booklet are a testament as to what was going on with a number of fantastic stories emerging from not only the Groups but also with the young people working within the communities. You will see at the back of the booklet there are list of awards, with some creative awards which we have done to award our young people for the work they have done within the communities. Neil wished to give a big thank you to everyone including the District Executive for supporting him over the last 12/18 months. Bearing in mind that we were locked down for 12/18 months there are a number of fantastic awards at all levels. Due to lockdown Neil was not able to get round the Groups to present the awards and will give these to the GSLs for them to present. He will get these all out now that we are back in Green.

He thanked everyone for their time and effort and emphasised that is why Cheadle is in such a strong position. He mentioned that the Youth Membership was down 25%, the Census the start of this year. The amount of joining enquiries we are now getting is phenomenal and most Groups are now getting a capacity point, he asked that they manage their waiting list as best they can and offer places at other Groups where possible now that Scouting is back on again.





Contingent Liabilities and Future Obligations

The Scout Council has a 50% share in the running of Abney Scout and Guide Residential Centre. Should the Centre incur losses, the Council may be called upon to contribute towards these losses.

The Scout Council has an obligation for rent payable in the future to Stockport Metropolitan Borough Council of £600 (six hundred pounds) per annum, subject to review, for the remainder of the lease i.e. 13 years.

Reserves

The District's policy on general reserves is to hold the following:

- £10,000 to enable it to help Groups in an emergency.
- £5,000 to cover replacement/renewal of Base Camp facilities.
- £10,000 to meet possible development of Base Camp headquarters.
- £10,000 to meet the anticipated costs of the District's future activities.
- £5,000 to contribute to Abney Scout & Guide Centre if losses should be incurred.

Property

"Base Camp" is occupied under a 21 year lease from the Metropolitan Borough Council of Stockport which commenced on 21st October 2013.
