Previous minutes were shared and agreed to be an accurate record.

Steve welcomed all to the AGM and thanked everyone who has supported our community this year. He shared a brief report of our achievements this year:~

- We now have a much larger committee with fifteen members. This ensures that we are able to share the load!
- Cosy Crawford/ warm space has taken place regularly on Wednesday mornings. Thank you to the volunteers who have organised these sessions.
- The development of the woodland walk is well underway and there have been many positive comments regarding this project.
- Thank you to all those who have continued to develop the grounds with benches, a willow tunnel, flower boxes etc. Also a big thank you to the 'grass cutting team' who keep the grounds looking amazing.
- A new Hyundai lawn mower has been purchased.
- The pirate ship has been repaired and painted. However, further repairs will be needed shortly.
- The hut was redecorated in October 2022.
- A trolley to store the tables in the hut was purchased.
- A very successful Christmas fair was held in December.
- The Christmas quiz was enjoyed by all who attended. Thank you to those who were involved in organising the event.
- Plans for Summer Fair for July 8th are all in place. Last year's fair was extremely successful.
- The external door to the rear is now being used for events that do not need access to the hut.
- The fencing to the road side has been repaired.
- We now have improved internet access.
- A Coleman dining shelter has been purchased and will be used for events such as the summer fair.
- Rainford Rangers FC will be using the field for matches in September.

- West Lancs CC have installed a new notice board at the front of the Hut.

Gareth gave an account of our current financial situation. Briefly, our closing balance is similar to last year and our annual expenditure is a little more than our income. Full accounts are available on request; final annual accounts will be completed at the end of July.

The following points were raised and discussed:

Future Purchases:

- Robot floor cleaner was suggested as some groups are still having to clean the floor prior to their session: Steve to research and share with the committee.
- Additional tables for the hall: to discuss at the next meeting
- Awning/canopy for the side of the hall to increase the use of outdoor space in wet weather: Steve to research

Dogs in the Hut:

The committee had agreed, several years ago that dogs, apart from assistance dogs, should not come into the Hut. We were made aware that during some sessions dogs had been coming into the building.

Following lengthy discussions, it was agreed that

- No dogs in the Hut unless it is a private booking with their own 'liability' insurance.
- The signs explaining no dogs apart from assistance dogs will be re sited on both entrance doors.
- Re-emphasise the 'no dogs' policy

Increase in rates for hiring the hut

This is due to the fact that our monthly income does not cover expenditure. A sub-committee suggested that from July fees will increase by:

- 10% for regular users
- 20% for 'one off' events.

Communication with the Community

It was brought to our attention that some members of the community have not been informed about or been involved in decisions made about the field usage near their properties. We agreed that we could improve communication by:

- Sharing any relevant information together with the agenda and the minutes of all community meetings via the mailing list and a hard copy posted on the village notice board.
- Advertise that any member of the community can attend the first fifteen minutes of any meeting to share any concerns. (This has always been the case).
- Continue to encourage more residents to join the mailing list.

Anti-social Behaviour

It was suggested that anyone witnessing the above should either report it to the police by phoning 101 or by completing the online report which can be found on the police website.

Decision Making

It was agreed that a sub-committee would develop a clear mechanism whereby decisions are made by the committee. This would be reported back to the whole committee for agreement at the next committee meeting. Mark, Mary, Karen, Louise, Heather, Catherine and Chris have volunteered for the group.
