Para 1.17 and 1.19	<p>There are regular activities and events for all ages, abilities and interests ranging from coffee mornings to historical presentations, knit-and-natter to family fun days and sports and leisure to education. We pride ourselves on running events which are inclusive for all and bring joy and fun to our local community such as scarecrow festivals, village celebrations, pantomimes, film nights, concerts, Christmas fayres and the highlight of the year; our annual summer show!</p> <p>We have recently launched a community café to promote the health and wellbeing of our residents and local community. Company and conversation promotes mental wellbeing, while providing a warm environment with inexpensive food and drink supports physical health.</p> <p>In addition to this we have regular fitness classes, history talks by our local U3A group and an upcoming art exhibition to further improve the lives of inhabitants by encouraging healthy practices and providing culture.</p>

Achievements and Performance

Summary of the main achievements of the charity, identifying the difference the charity's work has made to the circumstances of its beneficiaries and any wider benefits to society as a whole.	Para 1.20	The main achievement this year has been the renovation of the main hall and toilets. This work has insulated the main hall, and along with new energy-efficient heaters, ensured a much warmer and more comfortable environment for its users. The toilets have had all new sanitaryware and hygienic PVC cladding installed. Following the Covid-19 pandemic, having wipe-clean walls which provide active microbial protection and eliminate many types of mold, fungi and bacteria is a welcome addition to increase the health and safety of users. In addition, emergency fire exit doors to the rear of the building with push-pad opening mechanisms have further increased the safety of users by ensuring immediate escape from the building in case of an emergency. Finally, replacement of all lighting and emergency lighting for LED equivalents has reduced the running costs and helped increase the financial security of the building and charity. This will result in us being able to put more money back into the community through running social events.

The total expenditure was £50,111 of which £45,067 was spent on the renovation work and maintenance.</p> <p>The total opening balance was £15,930 and the closing balance was £19,246 which was an increase of £3,316 over the financial year.</p>


