REPORT OF THE TRUSTEES OF THE FRISBY ON THE WREAKE VILLAGE HALL FOR THE CALENDAR YEAR 2021

TRUSTEES of the Frisby on the Wreake Village Hall Trust are: Dianne Widdowson (Chair) Rodney Brooks by (Vice Chair), Delene East (Treasurer).
The Trust was registered as Charity No: 521419 with the Charity Commissioners in 1961.

COMMITTEE MEMBERS are Chair, Dianne Widdowson, Vice Chair Rodney Brooksby,, Treasurer , Delene East, Secretary, Lyn Hastings, Bookings Jo Burrows and members without portfolio - Nick Farrow, Ray Casey, Kate Stride, Jonathan Ball and Peter Culbert.

The committee runs the Hall principally for the public benefit of the people of Frisby but also for groups from further a field.

The land on which the Village Hall was built in 1961 was conveyed to the Committee free from encumbrances in 1951.

Insurances for buildings, contents and public liability etc are with Norris & Fisher Insurance Brokers.

RISK ASSESSMENT - annual contract to check the gas supply to the boiler and cookers has been entered into with a local heating engineer. This is part of on going risk assessment.

LICENSES HELD- Gambling Act 2005 with Melton Borough Council and Premises License to play recorded music with Performing Rights Society.

FINANCE - In 2021 regular receipts were lettings and 100 Club £3,568, Donations and Grants totalled £22,709. Payments etc totalled £4,538, leaving regular excess over income £21,739. New equipment and improvements (£25,296) Fund raising income net of costs £495. Net surplus from Fund Raising and Improvements (£24,801) Total excess of income over year (£3,062) with closing balance at 31.12.21 of £22,286.

The committee has adopted the policy that it will retain monetary resources to the value of at least six months running costs as a reserve.

The Receipts and Payment Account used in previous years met the requirements of the Charity Commission completely.

The 2021 Annual Accounts have been examined and agreed.

This report was approved at the meeting on 23.3.2022 and is signed by one Trustee on behalf of all the Trustees.
