A new flat roof was installed by Just roofing and this involved fundraising and expenditure that inflated the turnover over the norm of previous years.

Evington Youth Club's finances were in quite a healthy position in April 2021. Unfortunately, the club was forced to remain closed during April, May and June because of the Covid situation. At the same time, it was discovered that it was not possible to deal with a leaking roof by carrying out a simple repair. A new roof was required covering the main section of the building, costing £40,800.

The club did open on a few occasions in July but then was closed again for the whole of August while the new roof was being fitted. To pay for the new roof we were fortunate to receive grants from several charitable trusts as well as donations through a JustGiving page and from a number of anonymous donors. Some of this money had not come in at the time of paying the bill for the roof so the Chairman of the Trustees very kindly made an interest free loan of £12,500 available to the club, £6,900 of which remains to be paid off.

Thanks to the strong support of our local Councillors, the City Council has been very helpful in promising the club a new 20 year lease as from 01 October 2021 as well as providing £1,450 for new equipment and £2,000 towards the roof appeal. Unfortunately, we have not yet been successful in securing funding to support our core purpose by expanding the range of activities offered by the club to young people in Evington and the surrounding area but we are hopeful that we might begin to achieve that within the next few months.

In the meantime, in addition to the Friday evening club which was open pre-Covid and again from last September, we have been able to hold boxercise sessions for younger members on Saturday mornings thanks to specific donations made to the club via CAF. We are currently consulting parents in the Evington area about the kinds of activities that they would like to see offered for the benefit of their children and we are hopeful that we should soon be able to secure funding to support that development.

Finally, thanks to the hard work of volunteers organised for us by Leicester Rotary Club, the youth club is being redecorated and an increasing number of groups and individuals are seeking to hire the premises for both regular and one-off events. We therefore look forward to the finances being in an improved state in the near future.


