## TRUSTEES ANNUAL REPORT

### 3<sup>rd</sup> HINDLEY BOY SCOUT GROUP.

Financial Year 1<sup>st</sup> April 2023 - 31<sup>st</sup> March 2024

On the 4th of June 2023 our secretary sadly passed away. Sarah Heaton volunteered for the position and was elected on 10/11/23.

The trustees annual meeting took place on 17<sup>th</sup> April 2024 and the following trustees were present, Norman Brown, Robert Naylor, Patricia Wildon, Sarah Heaton, Gary Naylor, Stuart Farley and Helen Knight.

We hold an AGM each year where the annual accounts are agreed, the last one being on 4<sup>th</sup> September 2024.

The purpose of our charity is to promote Scouting in accordance with the Scout Association rules. We are governed by Royal Charter.

The Group pursues indoor and outdoor activities for Beaver, Cub and Scout sections. These activities not only encourage our young people to work in a team environment but also to equip them with knowledge and skills. This in turn boosts their self-confidence for later life.

We are a non-denominational group and are not affiliated to a Church or school. We rely on subscriptions, Grants, Grant Aid and fundraising for our income. We have a solid financial base and do not envisage any financial risk to our group in the future.

The 3<sup>rd</sup> Hindley Group is run solely by volunteers, growing to 100 members. The leaders, helpers, committee members and trustees give freely of their time to ensure the smooth running of the Group. The leaders, besides attending planning meetings and compulsory training such as Safety/ Safeguarding, also qualify in sporting disciplines such as archery, and kayaking. We aim to give our members a chance to experience alternative leisure pursuits and to equip them with life skills and goals to work towards.

Our income covers the maintenance of the interior and exterior of the building and utility bills. We run two vehicles; the running costs are also met by the Group. We also subsidise camps and activities.


We were fortunate enough to receive a grant from the Hindley & Abram Grammer School Foundation to purchase a newer van. This grant was for £20,000.00. We had applied for a smaller amount to go towards the purchase of a van, but the Foundation generously gave us the larger amount. This of course, greatly increased our income in the 2023-2024 year.


The year saw us purchase a newer van, new large gas heaters, a water boiler and new toilet fittings. All the light fittings in the main hall were replaced. A new consumer unit and safety lighting were also installed. Necessary work was undertaken to bring all the electrical fittings up to standard so that an Electrical Safety Certificate could be issued.

The last Charity Commission Independent Examiner's report was for the year 2020-2021. At the end of each financial year, I have the accounts scrutinised by my accountant. He has examined the 2023-2024 accounts and signed them off.

Annual meeting took place at Scout HQ on 8<sup>th</sup> December 2022.

Pamela Munroe our secretary/trustee retired after many years and we welcomed Karen Woods who will now take up this position.

The purpose of our charity is to promote Scouting in accordance with the Scout associations rules.

This pursuit is for the beavers, cubs and scouts to participate in indoor and outdoor scouting activities. These activities encourage our young people to not only work in a team, equip them with knowledge and skills but to also boost their self-confidence.

The trustees have had regard to the Charity Commission guidance.

We do not have a policy regarding grant making. Prior to the start of the Covid pandemic, as a non-denominational group, we relied on subscriptions, grant aid and our own fundraising. We have received, since the pandemic began, funds from our local council. We do not envisage any risks to our group.

We are governed by Royal Charter

The income received pays for the:  
maintenance and running of our headquarters  
running of our two vehicles (minibus and van)  
subsidising camps and camp activities.

Without our volunteers there would be no 3<sup>rd</sup> Hindley. Starting in 1957 we have grown to 100 + members. These volunteers, leaders, helpers and committee members are not paid and give a considerable amount of time ensure the smooth running of the group. They attend planning meetings and training in not only 1<sup>st</sup> Aid, but the different disciplines such as archery, kayaking etc.

Safety and Safeguarding training is also undertaken.

We give the young people in the area the chance to experience different and alternative leisure pursuits they may not otherwise have. We equip them with life skills and goals to work towards.

It is amazing to see a shy beaver going through the sections and achieving his Queens Scout Award. Not all of them do, however, we have scouts who have gone to university /armed forces who have returned to us and become leaders.

We held no meetings during our financial year 1-4-20 to 31-3-21 this was due to the Covid 19 pandemic.

I have enclosed a copy of the balance sheet and you will receive an auditor's report (as our income was over £25,000.00) from Ashurst Accountancy separately.

We try and keep a reserve of about £10,000.00 for unexpected expenses or if for any reason we do not have our usual income.

With the new Clean Air regulations coming into force, we are looking to replace our two old vehicles, a 2001 van and a 1996 minibus.

We now look forward to getting back to normal and continuing with our program for the coming year.
