### **STRUCTURE, GOVERNANCE AND MANAGEMENT**

The Groups governing documents are those of The Scout Association.

They consist of a Royal Charter, which in turn gives authority to the Bye Laws of the Association and The Policy, Organisation and Rules of The Scout Association.

The Group is a trust established under its rules which are common to all Scouts. The Trustees are appointed in accordance with the Policy, Organisation and Rules of The Scout Association.

The Group is managed by the Group Executive Committee, the members of which are the 'Charity Trustees' of the Scout Group which is an educational charity.

As charity trustees they are responsible for complying with legislation applicable to charities.

This includes the registration, keeping proper accounts and making returns to the Charity Commission as appropriate.

The Group Executive committee is the electoral body, which supports Scouting in the Group. It is the body to which the Group Executive Committee is accountable. The Executive Committee exists to support the District Commissioner in meeting the responsibilities of their appointment. Members of the Executive Committee must act collectively as charity Trustees of the Scout Group and in the best interests of its members in accordance with the Policy, Organisation and Rules of The Scout Association. The Group has in place systems of internal controls that are designed to provide reasonable assurance against material mismanagement or loss, these include 2 signatories for all payments.

The Group Finances continue to be in a healthy position as detailed in the Annual Statement of Accounts compiled in our report.

Our sections have maintained their numbers and our adult Leader numbers have increased by 4.

## **FINANCIAL REVIEW**

The accounts are presented in a Receipts and Payments format recommended the 'Charity Statement of Recommended Practice (SORP)', which forms part of The Scout Association Policy, Organization & Rules (POR).

The Group's Income and Expenditure is very small and therefore does not have sufficient funds to invest in longer-term investments such as stocks and shares. The Group has therefore adopted a low-risk strategy to the investment of its funds. All funds are held in cash using only mainstream banks or building societies.

The Group Executive regularly monitors the levels of bank balances and the interest rates received to ensure the Group obtains maximum value and income from its banking arrangements. Occasionally this may involve using an account that requires a period of notice before funds may be withdrawn, before doing so the Group Executive considers the cash flow requirements.

The Group's policy on reserves is to hold sufficient resources to continue the charitable activities of the Group Scout Council should income and fund-raising activities fall short. The Group Executive Committee considers that the Group should hold a sum equivalent to 12 months running costs, circa £ 16217.96. The Group held reserves of approximately £36,826.25 against this at year end.

The group exec has ring fenced £15,000 for refurbishment of building.
