2023 Chairman and Treasurer's Report

Edingale village hall is an independent charity that was first established in 1971. **This makes it our 52nd AGM.** Our Mission is to maintain the village hall, park and open space and to create community amenities, events and activities that help build a stronger community.

We are a small voluntary committee supported by hard-working volunteers.

In 2023, Thank you so much to the Events Committee who put in a massive amount of work to get events up and running.

We put on a great Summer Show, held a great theme night (thanks to Clare Keey) as well as regular Chaps / Ladies and family pub nights. The latter of these being poorly supported now which we have requested feedback into reasons why.

Our regular bookings are running well although numbers attending are down for some activities. We also have regular caravan clubs staying on the car park for the weekend.

The Solar panels have had batteries connected in early 2023 and we will shortly be evaluating the saving in electricity charges that we are achieving.

We have applied for a National Lottery grant towards the toilet upgrade and heating installation and are awaiting the outcome. We also obtained a small grant for recycling bins. 16 weeks needed to review 20K grant request

In the coming year we intend to upgrade the toilets (doors / skirting and flooring) and certainly have a plan to upgrade the heating and install it dependant on cost. These needs progressing over the next two months

The Parish Council have been very supportive as usual with the funding on play park repairs which will be carried forward on a yearly basis following the play park inspection.

For 2024, the programme of events has been set and we hope that the village support the setting up of these events and by attendance.

Many thanks to the committee, volunteers and public for their hard work and support.

Now we will read the Treasurers Report by Louise Maskery.

Finances in good shape due to covid grants

Cash and bank balances total just under £29,000. Regular hirers don't cover the regular costs (electricity etc) and we do need the regular events to boost funds. Summer show and chaps nights especially good find raisers.

All costs have increased. Parish council have agreed to help with play park repairs. Its very important we are careful with this money and spend wisely to protect building and repair costs.


Question from Anthony Mason – what the gap between regular hire and regular costs is (estimate is 2K). If we did not run events, we would be circa 2K down each year. Hires are mainly ad hoc (over £4000 caravan clubs, dog shows, school £1500). 2023 electricity was circa £4000 and insurance £2500.

We will now vote in the new committee.

The Village Hall finances are again in very good shape.

As stated last year, parts of the hall are still looking tired and we are continuously discussing ways to improve the hall

A copy of the income and expenditure account will be available at the end if anyone would like to look at it. Our cash and bank balances at the end of the year totalled £29,924 and currently stand at £28,964

As was the case last year, fundraising events help to cover regular out-goings which are not fully covered by regular hirers. The Summer show is always a good event both from a recreational point of view and as a source of much needed income. The monthly Chaps' Nights have also been both popular and profitable.

As I stated last year, the healthy bank balance is reassuring since we know that we have funds to cover unexpected repairs to the hall and the playground although the Parish Council has agreed to help fund repairs to the playground going forward I believe that it is important to continue to raise funds even though we currently appear to be very comfortable to ensure that the village hall is sustained for future generations.

Many thanks to everyone who has helped at events and in the day to day running of the hall.

Edingale village hall is an independent charity that was first established in 1971 (Nora Mason was chair). **This makes it our 50th AGM.** Our Mission is to maintain the village hall, park and open space and to create community amenities, events and activities that help build a stronger community.

We are a small voluntary committee supported by hard-working volunteers.

In 2021, we did our best to start the journey back to normality but with safety at the forefront. We started the Tea Dance which is proving a valuable social activity for our over 50's. We had a grant for football, providing two free football sessions every Sunday morning. We tried friendly Fridays with food wagons but this did not get good support. We had quiz nights, bingo, and a theme night - all a great hit and again, our summer show was a huge success.

For 2022, the programme of events now is nearing 40 events including a new pub night (whilst pub is closed).

As for improvements, the park is inspected weekly. We have spent £700 already this year on the zip wire and tree house, it must be safe! Heating is a priority this year and we are also having a new front door fitted. We are working with an architect to help us refurbish and extend the village hall. Once we have draft plans, we will start public consultation and seek grant funding.

WH and CD are keeping the hall clean and are now carrying out extended caretaking duties for us.

LP keeps our finances in good order and has spent time on insurance matters and COVID safety and risk assessments.

In summary, we have put public safety at the foremost but continued community and public activities and events, as far as possible.

Many thanks to the committee, volunteers and public for their hard work and support.

We will now vote in the new committee.

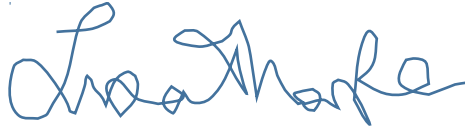

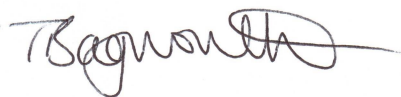

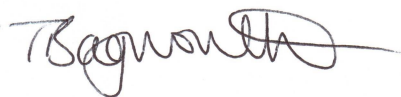
