Objectives and Activities

To hold the property identified in the Deed of Gift, to be known as "The Mary Stevens Park", as public pleasure grounds, and to support, improve and maintain the property for this purpose and in accordance with the conditions set out in the Deed of Gift.

The Trustees have had regard to the guidance issued by the Charity Commission on public benefit.

Achievements and Performance

The Charity has received income in the financial year relating to trading activities. It has also received income from the Council as a contribution to the costs of maintenance of grounds and property.

The Council recognises the substantial benefits provided to the local community and to the Council by the Recreation Ground and Park, and notes that there is an active Friends Group and other volunteers who work tirelessly on behalf of the Park.

Expenditure during the financial year related to grounds maintenance and the running costs, maintenance and improvement of the buildings, primarily Studley Court, which is currently used as Council office accommodation.

Financial Review

The Charity has received income in the financial year from trading activities of £67,571 relating mainly to recreation charges, rent from the café and the ice cream concession. It has also received income from Council support of £345,356.

This has met the costs in the financial year of £412,927 on maintenance of grounds and property. Building running costs were £189,8289 which includes £10,544 spent on routine repairs. Grounds maintenance costs for the year were £223,098, mainly provided by the Council's Greencare team.

The Charity does not generally hold reserves. If income received from service charges or other income relating to occupation of the premises is not sufficient to meet the costs of maintenance, the Council will make the required contribution to break even in the year.

The property is currently valued at £2,786,324. It has been revalued in 2025.

The Charity currently has no investments.

Structure, Governance and Management

The charity was established by the Deed of Gift made on 6 December 1929 between Ernest Stevens of Prescott House, Stourbridge and the Mayor, Aldermen and Burgesses of the Borough of Stourbridge.

The Trustee of the Charity is Dudley Metropolitan Borough Council. The Ernest Stevens Management Committee has been created with the delegated power of the Trustee.

Objectives and Activities

To hold the property identified in the Deed of Gift, to be known as "The Mary Stevens Park", as public pleasure grounds, and to support, improve and maintain the property for this purpose and in accordance with the conditions set out in the Deed of Gift.

The Trustees have had regard to the guidance issued by the Charity Commission on public benefit.

Achievements and Performance

The Charity has received income in the financial year relating to trading activities. It has also received income from the Council as a contribution to the costs of maintenance of grounds and property.

The Council recognises the substantial benefits provided to the local community and to the Council by the Recreation Ground and Park, and notes that there is an active Friends Group and other volunteers who work tirelessly on behalf of the Park.

Expenditure during the financial year related to grounds maintenance and the running costs, maintenance and improvement of the buildings, primarily Studley Court, which is currently used as Council office accommodation.

Financial Review

The Charity has received income in the financial year from trading activities of £66,894 relating mainly to recreation charges, rent from the café and the ice cream concession. It has also received income from Council support of £421,086.

This has met the costs in the financial year of £487,980 on maintenance of grounds and property. Building running costs were £231,972, which includes £29,453 spent on routine repairs. Grounds maintenance costs for the year were £256,008, mainly provided by the Council's Greencare team.

The Charity does not generally hold reserves. If income received from service charges or other income relating to occupation of the premises is not sufficient to meet the costs of maintenance, the Council will make the required contribution to break even in the year.

The property is currently valued at £1,700,000. It has been revalued in 2020 and there has been no change in valuation.

The Charity currently has no investments.

Structure, Governance and Management

The charity was established by the Deed of Gift made on 6 December 1929 between Ernest Stevens of Prescott House, Stourbridge and the Mayor, Aldermen and Burgesses of the Borough of Stourbridge.

The Trustee of the Charity is Dudley Metropolitan Borough Council. The Ernest Stevens Management Committee has been created with the delegated power of the Trustee.

Objectives and Activities

To hold the property identified in the Deed of Gift, to be known as "The Mary Stevens Park", as public pleasure grounds, and to support, improve and maintain the property for this purpose and in accordance with the conditions set out in the Deed of Gift.

The Trustees have had regard to the guidance issued by the Charity Commission on public benefit.

Achievements and Performance

The Charity has received income in the financial year relating to trading activities. It has also received income from the Council as a contribution to the costs of maintenance of grounds and property.

The Council recognises the substantial benefits provided to the local community and to the Council by the Recreation Ground and Park, and notes that there is an active Friends Group and other volunteers who work tirelessly on behalf of the Park.

Expenditure during the financial year related to grounds maintenance and the running costs, maintenance and improvement of the buildings, primarily Studley Court, which is currently used as Council office accommodation.

Financial Review

The Charity has received income in the financial year from trading activities of £62,291 relating mainly to recreation charges, rent from the café and the ice cream concession. It has also received income from Council support of £425,663.

This has met the costs in the financial year of £487,954 on maintenance of grounds and property. Building running costs were £224,407, which includes £40,720 spent on routine repairs. Grounds maintenance costs for the year were £263,547, mainly provided by the Council's Greencare team.

The Charity does not generally hold reserves. If income received from service charges or other income relating to occupation of the premises is not sufficient to meet the costs of maintenance, the Council will make the required contribution to break even in the year.

The property is currently valued at £1,700,000. It has been revalued in 2020 and there has been no change in valuation.

The Charity currently has no investments.

Structure, Governance and Management

The charity was established by the Deed of Gift made on 6 December 1929 between Ernest Stevens of Prescott House, Stourbridge and the Mayor, Aldermen and Burgesses of the Borough of Stourbridge.

The Trustee of the Charity is Dudley Metropolitan Borough Council. The Ernest Stevens Management Committee has been created with the delegated power of the Trustee.

Objectives and Activities

To hold the property identified in the Deed of Gift, to be known as "The Mary Stevens Park", as public pleasure grounds, and to support, improve and maintain the property for this purpose and in accordance with the conditions set out in the Deed of Gift.

The Trustees have had regard to the guidance issued by the Charity Commission on public benefit.

Achievements and Performance

The Charity has received income in the financial year relating to trading activities. It has also received income from the Council as a contribution to the costs of maintenance of grounds and property.

The Council recognises the substantial benefits provided to the local community and to the Council by the Recreation Ground and Park, and notes that there is an active Friends Group and other volunteers who work tirelessly on behalf of the Park.

Expenditure during the financial year related to grounds maintenance and the running costs, maintenance and improvement of the buildings, primarily Studley Court, which is currently used as Council office accommodation.

Financial Review

The Charity has received income in the financial year from trading activities of £69,610 relating mainly to recreation charges, rent from the café and the ice cream concession. It has also received income from Council support of £369,020.

This has met the costs in the financial year of £438,630 on maintenance of grounds and property. Building running costs were £198,790, which includes £37,689 spent on routine repairs. Grounds maintenance costs for the year were £239,840, mainly provided by the Council's Greencare team.

The Charity does not generally hold reserves. If income received from service charges or other income relating to occupation of the premises is not sufficient to meet the costs of maintenance, the Council will make the required contribution to break even in the year.

The property is currently valued at £1,700,000. It has been revalued in 2020 and there has been no change in valuation.

The Charity currently has no investments.

Structure, Governance and Management

The charity was established by the Deed of Gift made on 6 December 1929 between Ernest Stevens of Prescott House, Stourbridge and the Mayor, Aldermen and Burgesses of the Borough of Stourbridge.

The Trustee of the Charity is Dudley Metropolitan Borough Council. The Ernest Stevens Management Committee has been created with the delegated power of the Trustee.

Objectives and Activities

To hold the property identified in the Deed of Gift, to be known as "The Mary Stevens Park", as public pleasure grounds, and to support, improve and maintain the property for this purpose and in accordance with the conditions set out in the Deed of Gift.

The Trustees have had regard to the guidance issued by the Charity Commission on public benefit.

Achievements and Performance

The Charity has received income in the financial year relating to trading activities. It has also received income from the Council as a contribution to the costs of maintenance of grounds and property.

The Council recognises the substantial benefits provided to the local community and to the Council by the Recreation Ground and Park, and notes that there is an active Friends Group and other volunteers who work tirelessly on behalf of the Park.

Expenditure during the financial year related to grounds maintenance and the running costs, maintenance and improvement of the buildings, primarily Studley Court, which is currently used as Council office accommodation.

Financial Review

The Charity has received income in the financial year from trading activities of £62,783 relating mainly to recreation charges, rent from the café and the ice cream concession. It has also received income from Council support of £338,754.

This has met the costs in the financial year of £401,537 on maintenance of grounds and property. Building running costs were £141,781, with £14,992 spent on routine repairs. Grounds maintenance costs for the year were £244,764, mainly provided by the Council's Greencare team.

The Charity does not generally hold reserves. If income received from service charges or other income relating to occupation of the premises is not sufficient to meet the costs of maintenance, the Council will make the required contribution to break even in the year.

The property is currently valued at £1,700,000. It has been revalued in 2020 and there has been no change in valuation.

The Charity currently has no investments.

Structure, Governance and Management

The charity was established by the Deed of Gift made on 6 December 1929 between Ernest Stevens of Prescott House, Stourbridge and the Mayor, Aldermen and Burgesses of the Borough of Stourbridge.

The Trustee of the Charity is Dudley Metropolitan Borough Council. The Ernest Stevens Management Committee has been created with the delegated power of the Trustee.
