The charity is managed by way of a formal committee of volunteers. The committee is separate from the Trustees. The committee ensures the smooth running of the charity. Officers and trustees were recruited during committee meetings.

The objective of the charity is to offer a community hub for the community but can also be hired out to outsiders including local authority, private companies, private persons and an array of groups with all proceeds being ploughed back into the charity to ensure the upkeep, maintenance and improvements to the building and the surrounding site, all for the benefit of the community.

Having been dormant for a few years during and after covid, a new committee took over the running of the hall in 2023 and great improvements were made by way of grants, rental and donations. The grants received went towards improvements to the play area outside and also towards fixing the damaged roof where water had been leaking in and causing damage in the roofspace and the kitchen. The work was not done in this financial year but in the following financial year.

Although the committee only started out and remedial work was not started, the charity held it's head with bills etc in anticipation of the hall becoming a brighter, safer and nicer place for the community to use.
