REPORT OF THE TRUSTEES FOR THE YEAR ENDED 31 DECEMBER 2024

The trustees present their report along with the financial statements of the charity for the year ended 31 December 2024. The financial statements have been prepared in accordance with the accounting policies set out in note 1 to the accounts which can be found on page 7 and comply with the charities trust deed, applicable law and the Charities SORP FRS 102.

Constitution, Objectives and Activities for the Public Benefit

The charity is constituted by a Scheme dated 25 February 2003 and was registered on 10 January 1962 with the number 523945.

Its objects are to provide a recreation ground and a welfare institute for the purposes of exercise and recreation for use by those who are workers in and around coal mines in the parish of South Kirkby and Moorthorpe.

The trustees have referred to the guidance given by the Charity Commission on public benefit when reviewing the charity's aims and objectives and details of the activities that have taken place during the year can be found later in this report.

Organisational Structure

The trustees who have served the charity during the year are shown on page 1.

The charity is responsible for maintaining the premises and its contents and grounds in a suitable state of repair for use by those who live in the surrounding area. It raises income through various charitable activities, the main one being the hiring out of its facilities to the general public, but a substantial amount of its income comes from its connected trading company, South Kirkby Colliery Miners' Welfare Scheme Social Club Limited, which pays an annual occupational licence fee to the charity in order to run its business from the Charity's premises. In addition to this, the company also transfers any profits it makes to the charity under a Gift Aid agreement so the trustees work closely with the directors to try and ensure the company is profitable, thus ensuring extra income for the charity.

Trustee vacancies are advertised and interested parties are asked to apply in writing. Interviews will be held and suitable candidates are then notified to their nominating body being either CISWO, Trade Union or members. The Trustee Board is made up of equal numbers of each nominating body.

Financial Review

The trustees consider this has been an improved year from the day to day running of the welfare with a deficit of £1,692 (2023 deficit £5,387). Further improvements and repairs have been undertaken which have improved the facilities, although savings have been made in energy costs other expenses have increased, this along with a deficit of £15,403 for the connected ssections has resulted in an overall decrease in funds. In 2024 the total movements in funds was a deficit of £17,224 (2023: surplus of £2,491).

Review Of Activities

During the year the trust has been able to continue to undertake improvements to the buildings and grounds so as to maintain and extend their use. This is an ongoing situation with trustees continually monitoring and assessing projects and suggestions. Full use has been made of the facilities available and the sections have again been active throughout the year. The trustees would like to thank the continued support of the many individuals who give their work and efforts, voluntarily, in maintaining, promoting and supporting the various sections and the Charity itself.

Investment Policy

The charity does not have investment policy in place as such but the trustees have taken the sensible approach and have placed most of the liquid assets in interest bearing bank accounts.

Reserves Policy

It is the policy of the trustees to maintain unrestricted funds which are the free reserves of the charity, at a level to provide sufficient funds to cover anticipated administration and support costs for a period of 12 months. Any additional reserves are held to provide a capital fund for repairs that will be required for the upkeep of the premises.

Risk Management


The trustees are aware of the operational and financial risks which the charity faces and regularly reviews those risks to mitigate against any impact they may have on the charity. The major risks facing the charity are the continued success of the social club from which it derives its main funding, the support of individuals and the community in using the facilities and the introduction of the younger generation to provide for the future. The trustees work closely with directors, committee and members to address these risks.


Statement of Trustees' Responsibilities

As the charities trustees you are responsible for the preparation of the accounts in accordance with the requirements of the Charities Act 2011 (the Act).







1. ACCOUNTING POLICIES

a) Basis of preparation and assessment of going concern

The financial statements have been prepared under the historical cost convention unless otherwise stated in the relevant notes to these accounts. The financial statements have been prepared in accordance with the Statement of Recommended Practice: Accounting and Reporting by Charities (FRS102), the Financial Reporting Standard (FRS102) and the Charities Act 2011.

The trustees consider that there are no material uncertainties about the Trust's ability to continue as a going concern. The trustees have a reasonable expectation that the Trust has adequate reserves to continue in operational existence for the foreseeable future. Accordingly the trustees continue to adopt the going concern basis in the preparation of the accounts.

b) Income Recognition

Income is recognised once the Charity has entitlement to the income, it is probable that the income will be received and the amount of income receivable can be measured reliably.

Donations are recognised when they are received.

c) Expenditure recognition

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that settlement will be required and the amount of the obligation can be measured reliably. All expenditure is accounted for on an accruals basis.

2. RESTRICTED FUNDS - GRANTS RECEIVED

A grant was received during the year ended 31 December 1998 from the English Sports Council, on the recommendation of the Lottery Awards Panel, to provide assistance in the financing of additions and improvements to the sporting facilities. These included a new floodlit crown green, floodlighting for the football pitch, changing room upgrade, cricket practice area, boundary fencing, ground equipment and car parking.

The total grant received amounted to £106,408 and the excess cost of the work required was funded directly from unrestricted funds. The grant has been credited to a restricted fund, against which the depreciation of these improvements was charged. This grant has now been fully written down.

During 2020 there was a grant of £2,500 received from the South Kirkby and Hemsworth Miners Welfare Fund. This grant came with the condition that it should be used towards an old folk's treat and was added to the restricted fund.

3. STAFF COSTS

No remuneration was paid to the trustees in the year and no staff costs were incurred. (2023: Nil)

4. DONATIONS

Donations were received during the year from cricket, football, pigeon auctions, tickers and Slimming World.

During the previous year a donation of £12,540 was received from South Kirkby Colliery Cricket Club

The charity is responsible for maintaining the premises and its contents and grounds in a suitable state of repair for use by those who live in the surrounding area. It raises income through various charitable activities, the main one being the hiring out of its facilities to the general public, but a substantial amount of its income comes from its connected trading company, South Kirkby Colliery Miners' Welfare Scheme Social Club Limited, which pays an annual occupational licence fee to the charity in order to run its business from the Charity's premises. In addition to this, the company also transfers any profits it makes to the charity under a Gift Aid agreement so the trustees work closely with the directors to try and ensure the company is profitable, thus ensuring extra income for the charity.

Trustee vacancies are advertised and interested parties are asked to apply in writing. Interviews will be held and suitable candidates are then notified to their nominating body being either CISWO, Trade Union or members. The Trustee Board is made up of equal numbers of each nominating body.

Financial Review

The trustees consider this has been a less disappointing year mainly due to being fully reopened after the COVID situation. Although further improvements and repairs have been undertaken which have improved the facilities, incoming resources have improved in the year but the expenditure has increased, especially energy costs. This has resulted in an overall decrease in day to day funds. In 2022 the total movements in funds was a surplus of £2,491 (2022: deficit of £14,346).

Review Of Activities

During the year the trust has been able to continue to undertake improvements to the buildings and grounds so as to maintain and extend their use. This is an ongoing situation with trustees continually monitoring and assessing projects and suggestions. Full use has been made of the facilities available and the sections have again been active throughout the year. The trustees would like to thank the continued support of the many individuals who give their work and efforts, voluntarily, in maintaining, promoting and supporting the various sections and the Charity itself.





1. ACCOUNTING POLICIES

a) Basis of preparation and assessment of going concern

The financial statements have been prepared under the historical cost convention unless otherwise stated in the relevant notes to these accounts. The financial statements have been prepared in accordance with the Statement of Recommended Practice: Accounting and Reporting by Charities (FRS102), the Financial Reporting Standard (FRS102) and the Charities Act 2011.

The trustees consider that there are no material uncertainties about the Trust's ability to continue as a going concern. The trustees have a reasonable expectation that the Trust has adequate reserves to continue in operational existence for the foreseeable future. Accordingly the trustees continue to adopt the going concern basis in the preparation of the accounts.

b) Income Recognition

Income is recognised once the Charity has entitlement to the income, it is probable that the income will be received and the amount of income receivable can be measured reliably.

Donations are recognised when they are received.

c) Expenditure recognition

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that settlement will be required and the amount of the obligation can be measured reliably. All expenditure is accounted for on an accruals basis.

2. RESTRICTED FUNDS - GRANTS RECEIVED

A grant was received during the year ended 31 December 1998 from the English Sports Council, on the recommendation of the Lottery Awards Panel, to provide assistance in the financing of additions and improvements to the sporting facilities. These included a new floodlit crown green, floodlighting for the football pitch, changing room upgrade, cricket practice area, boundary fencing, ground equipment and car parking.

The total grant received amounted to £106,408 and the excess cost of the work required was funded directly from unrestricted funds. The grant has been credited to a restricted fund, against which the depreciation of these improvements is charged.

During 2020 there was a grant of £2,500 received from the South Kirkby and Hemsworth Miners Welfare Fund. This grant came with the condition that it should be used towards an old folk's treat and has been added to the restricted fund.

3. STAFF COSTS

No remuneration was paid to the trustees in the year and no staff costs were incurred. (2021: Nil)

REPORT OF THE TRUSTEES FOR THE YEAR ENDED 31 DECEMBER 2021

The trustees present their report along with the financial statements of the charity for the year ended 31 December 2021. The financial statements have been prepared in accordance with the accounting policies set out in note 1 to the accounts which can be found on page 7 and comply with the charities trust deed, applicable law and the Charities SORP FRS 102.

Constitution, Objectives and Activities for the Public Benefit

The charity is constituted by a Scheme dated 25 February 2003 and was registered on 10 January 1962 with the number 523945.

Its objects are to provide a recreation ground and a welfare institute for the purposes of exercise and recreation for use by those who are workers in and around coal mines in the parish of South Kirkby and Moorthorpe.

The trustees have referred to the guidance given by the Charity Commission on public benefit when reviewing the charity's aims and objectives and details of the activities that have taken place during the year can be found later in this report.

Organisational Structure

The trustees who have served the charity during the year are shown on page 1.

The charity is responsible for maintaining the premises and its contents and grounds in a suitable state of repair for use by those who live in the surrounding area. It raises income through various charitable activities, the main one being the hiring out of its facilities to the general public, but a substantial amount of its income comes from its connected trading company, South Kirkby Colliery Miners' Welfare Scheme Social Club Limited, which pays an annual occupational licence fee to the charity in order to run its business from the Charity's premises. In addition to this, the company also transfers any profits it makes to the charity under a Gift Aid agreement so the trustees work closely with the directors to try and ensure the company is profitable, thus ensuring extra income for the charity.

Trustee vacancies are advertised and interested parties are asked to apply in writing. Interviews will be held and suitable candidates are then notified to their nominating body being either CISWO, Trade Union or members. The Trustee Board is made up of equal numbers of each nominating body.

Financial Review

The trustees consider this has been a disappointing year mainly due to the COVID situation. Although further improvements and repairs have been undertaken which has improved the facilities, incoming resources have slightly increased in the year and the expenditure has also increased which resulted in an overall decrease in funds. In 2021 the total movements in funds was a deficit of £29,458 (2020: £16,571).

Review Of Activities

During the year the trust has been able to continue to undertake improvements to the buildings and grounds so as to maintain and extend their use. This is an ongoing situation with trustees continually monitoring and assessing projects and suggestions. Full use has been made of the facilities available and the sections have again been active throughout the year. The trustees would like to thank the continued support of the many individuals who give their work and efforts, voluntarily, in maintaining, promoting and supporting the various sections and the Charity itself.

Investment Policy

The charity does not have investment policy in place as such but the trustees have taken the sensible approach and have placed most of the liquid assets in interest bearing bank accounts.

Reserves Policy

It is the policy of the trustees to maintain unrestricted funds which are the free reserves of the charity, at a level to provide sufficient funds to cover anticipated administration and support costs for a period of 12 months. Any additional reserves are held to provide a capital fund for repairs that will be required for the upkeep of the premises.

Risk Management

The trustees are aware of the operational and financial risks which the charity faces and regularly reviews those risks to mitigate against any impact they may have on the charity. The major risks facing the charity are the continued success of the social club from which it derives its main funding, the support of individuals and the community in using the facilities and the introduction of the younger generation to provide for the future. The trustees work closely with directors, committee and members to address these risks.

Impact of COVID 19

In line with Government direction, the charity ceased all activities in March 2020 and again in November 2020. At the time of signing these accounts, activities are slowly getting back to normal and the premises are now fully open following best practice guidance available. The long term impact of the pandemic on the activities and finances of the charity cannot be assessed at the time of signing these accounts.

The Trustees are carefully managing the charity's finances and are satisfied that it will be able to continue to meet its obligations for the foreseeable future.



A grant was received during the year ended 31 December 1998 from the English Sports Council, on the recommendation of the Lottery Awards Panel, to provide assistance in the financing of additions and improvements to the sporting facilities. These included a new floodlit crown green, floodlighting for the football pitch, changing room upgrade, cricket practice area, boundary fencing, ground equipment and car parking.

The total grant received amounted to £106,408 and the excess cost of the work required was funded directly from unrestricted funds. The grant has been credited to a restricted fund, against which the depreciation of these improvements is charged.

During 2020 there was a grant of £2,500 received from the South Kirkby and Hemsworth Miners Welfare Fund. This grant came with the condition that it should be used towards an old folk's treat and has been added to the restricted fund.

3. STAFF COSTS

No remuneration was paid to the trustees in the year and no staff costs were incurred. (2020: Nil)

REPORT OF THE TRUSTEES FOR THE YEAR ENDED 31 DECEMBER 2020

The trustees present their report along with the financial statements of the charity for the year ended 31 December 2020. The financial statements have been prepared in accordance with the accounting policies set out in note 1 to the accounts which can be found on page 7 and comply with the charities trust deed, applicable law and the Charities SORP FRS 102.

Constitution, Objectives and Activities for the Public Benefit

The charity is constituted by a Scheme dated 25 February 2003 and was registered on 10 January 1962 with the number 523945.

Its objects are to provide a recreation ground and a welfare institute for the purposes of exercise and recreation for use by those who are workers in and around coal mines in the parish of South Kirkby and Moorthorpe.

The trustees have referred to the guidance given by the Charity Commission on public benefit when reviewing the charity's aims and objectives and details of the activities that have taken place during the year can be found later in this report.

Organisational Structure

The trustees who have served the charity during the year are shown on page 1.

The charity is responsible for maintaining the premises and its contents and grounds in a suitable state of repair for use by those who live in the surrounding area. It raises income through various charitable activities, the main one being the hiring out of its facilities to the general public, but a substantial amount of its income comes from its connected trading company, South Kirkby Colliery Miners' Welfare Scheme Social Club Limited, which pays an annual occupational licence fee to the charity in order to run its business from the Charity's premises. In addition to this, the company also transfers any profits it makes to the charity under a Gift Aid agreement so the trustees work closely with the directors to try and ensure the company is profitable, thus ensuring extra income for the charity.

Trustee vacancies are advertised and interested parties are asked to apply in writing. Interviews will be held and suitable candidates are then notified to their nominating body being either CISWO, Trade Union or members. The Trustee Board is made up of equal numbers of each nominating body.

Financial Review

The trustees consider this has been a disappointing year mainly due to the COVID situation. Although further improvements and repairs have been undertaken which has improved the facilities, incoming resources have decreased in the year and the expenditure has also decreased which resulted in an overall decrease in funds. In 2020 the total movements in funds was a deficit of £16,571 (2019: £18,546).

Review Of Activities

During the year the trust has been able to continue to undertake improvements to the buildings and grounds so as to maintain and extend their use. This is an ongoing situation with trustees continually monitoring and assessing projects and suggestions. Full use has been made of the facilities available and the sections have again been active throughout the year. The trustees would like to thank the continued support of the many individuals who give their work and efforts, voluntarily, in maintaining, promoting and supporting the various sections and the Charity itself.

Investment Policy

The charity does not have investment policy in place as such but the trustees have taken the sensible approach and have placed most of the liquid assets in interest bearing bank accounts.

Reserves Policy

It is the policy of the trustees to maintain unrestricted funds which are the free reserves of the charity, at a level to provide sufficient funds to cover anticipated administration and support costs for a period of 12 months. Any additional reserves are held to provide a capital fund for repairs that will be required for the upkeep of the premises.

Risk Management

The trustees are aware of the operational and financial risks which the charity faces and regularly reviews those risks to mitigate against any impact they may have on the charity. The major risks facing the charity are the continued success of the social club from which it derives its main funding, the support of individuals and the community in using the facilities and the introduction of the younger generation to provide for the future. The trustees work closely with directors, committee and members to address these risks.

Impact of COVID 19

In line with Government direction, the charity ceased all activities in March 2020 and again in November 2020. The trustees plan to resume activity at a time considered appropriate and when allowed to do so, obviously following best practice guidance available at that time. The long term impact of the pandemic on the activities and finances of the charity cannot be assessed at the time of signing these accounts.


The Trustees are carefully managing the charity's finances and are satisfied that it will be able to continue to meet its obligations for the foreseeable future.

Statement of Trustees' Responsibilities


