**Objects:** THE PROVISION AND MAINTENANCE OF A SOCIAL WELFARE CENTRE, A RECREATION GROUND, A PLAYING FIELD AND A COMMUNITY CENTRE FOR THE BENEFIT OF THE INHABITANTS OF THE BENEFICIAL AREA WITHOUT DISTINCTION OF SEX, OR OF POLITICAL, RELIGIOUS OR OTHER OPINIONS, AND IN PARTICULAR FOR USE FOR MEETINGS, LECTURES, CLASSES, PHYSICAL EXERCISE AND OTHER FORMS OF RECREATION AND LEISURE-TIME OCCUPATION.

**Activities:** The provision and maintenance of a social welfare centre, a recreation ground, a playing field and a community centre for the benefit of the inhabitants of the beneficial area without distinction of sex, or of political, religious or other opinions, and in particular for use for meetings, lectures, classes, physical exercise and other forms of recreation and leisure-time occupation.
