Additionally other regular users include Dog Training groups, Needlework and a pop in centre for the very local users.

Summary of the main achievements of the charity during the year

The period covered by this report has been very different due to the Covid-19 pandemic and much of the time being unused due to national restrictions in place.

Consequently the actual hiring income was very low. However due to the efforts of the Management Committee and in particular the Clerk to the Local Community Council a number of grants were secured (£24,000 in total) which takes the total income into the band requiring a trustees report and independent review of accounts which has been completed and will be submitted along with this report.
