Structure, governance and management

Constitution

The Group is a trust established under its rules which are common to all Groups.

Appointment of trustees

Trustees are appointed in accordance with the Policy, Organisation & Rules of The Scout Association.

Objectives and Activities

We have referred to the guidance contained in the Charity Commission's general guidance on Public Benefit when reviewing our aims and objectives and in planning our future activities. In particular, the trustees consider how planned activities will contribute to the aims and objectives they have set.

Objectives

The objectives of the group are to promote and encourage Scouting in Silverdale in accordance with the aim of The Scout Association.

The group relies on volunteers for the running of all sections and the administration of the group.

The group will continue its close association with St Luke's Church in Silverdale.

Activities

The year started with much restriction still in place because of Covid and although the group sections could meet outside this still made things difficult. The older children did meet to go on walks and other activities within our grounds but things were still difficult. As restrictions were lifted through the year things started to get back to normal with badge work and camping for the older children starting up again. We hope that in 2022 things will be back to normal and all children can enjoy going to camps and on hikes. The sections still managed a large amount of badge work with children gaining the highest award for their section before moving up to the next section.

Achievements and performance

We did manage to participate in some community activities though these were still restricted. We attended a recruitment day for Scouting at Keele University and the Scout section helped Newcastle Borough Council with the planting at the Mining Monument in Silverdale. Some of the other community activities that we try to be involved in still did not take place in 2021 but we are hoping that we can do more in 2022.

Financial review

Finances

There is a surplus of receipts against payments of £31,400 for the year (2021 surplus £20,901) being £31,399 on general reserves (2021 surplus £20,899) and £1 surplus on restricted funds (2021 £2 surplus).

At the end of the year reserves amounted to £70,591(2021 £39,192) general £69,460 restricted £1,132 (2021 £38,061 general £1,131 restricted).

There were no funds in deficit at the year end.

Reserves

The Group's policy on reserves is to hold an amount to enable it to maintain the Headquarters for 6 months, the current level of reserves is considered adequate for this purpose.

Risks

The Trustees have identified the major risks to which they believe the Group is exposed. They have reviewed these and established systems to mitigate them.

Officers' Responsibilities

Under the Charities Acts, the trustees are required to prepare financial statements for each financial year which properly present the state of affairs of the charity as at the end of the financial year and of the excess of income over expenditure for the financial year. They are also responsible for preparing the financial statements on a consistent basis.

The trustees have responsibility for ensuring that the charity keeps accounting records which disclose with reasonable accuracy the financial position of the charity and which enable them to ensure that they comply with the Trust Deed and Charities Acts.

The trustees have general responsibility for taking such steps as are reasonably open to them to safeguard the assets of the charity and to prevent and detect fraud and other irregularities. Risks are reviewed and identified and steps taken to mitigate such risks as necessary.

Notes to the Financial Statements for the year ended 31st March 2022

1. Accounting policies

Basis of preparation

The financial statements have been prepared under the historical cost accounting rules and the Statement of Recommended Practice FRS102.

The accounts have been prepared on a receipts and payments basis.

Income recognition

Income is recognised when received.

Expenditure

Expenditure is charged as paid inclusive of irrecoverable value added tax.

2. Subscriptions

As stated in the accounting policy, subscriptions are accounted for on a cash basis and are included in income when they are received.

3. Land and Buildings

The group owns land and buildings in Vale Street, Silverdale. The original cost of the land £200 and the cost of erecting the Buildings was £1,500 in 1963/1964. The group has not obtained a recent valuation. Expenditure related to the building of a new headquarters is charged against grant funding which is being obtained for the purpose.

Title deeds are held on the Groups behalf by the Scout Association Trust Corporation.

4. Equipment

The group owns various items of equipment including tents, trailers and other camping equipment, some of which has been purchased through restricted funds. All of the expenditure for this equipment has been charged to the relevant fund when made.

5. Other Grants

A grant of £8,000 was received from Newcastle under Lyme Revenue Support.
