(2) IN PROMOTING THE EDUCATION (INCLUDING SOCIAL AND PHYSICAL TRAINING) OF PERSONS UNDER THE AGE OF 25 YEARS WHO OR WHOSE PARENTS ARE RESIDENT IN THE AREA OF BENEFIT WHO HAVE AT ANY TIME ATTENDED AS A PUPIL AT BUILTH WELLS HIGH SCHOOL AND WHO ARE IN NEED OF FINANCIAL ASSISTANCE.
