ADDITIONALLY, SUMS OF MONEY TO SUPPORT EDUCATIONAL INITIATIVES INCLUDING THE THREE PRIMARY SCHOOLS OR THE COLLEGE IN THE AREA OF BENEFIT, TO ACHIEVE SUCCESS IN SPECIAL EDUCATIONAL PROJECTS THAT WILL PROVIDE LONG-LASTING BENEFITS TO ALL OF THEIR PUPILS OR STUDENTS.

Activities: Makes grants to individuals to help them with their education. Offers grants, generally in the form of one-off payments to persons or families in financial need. Before awards are made, the financial backgrounds of applicants are checked by questionnaire. Supports educational projects in local primary schools, in areas not funded by the local authority.
