PETER, ABERDOVEY, AND THE ECCLESIASTICAL PARISH OF PENNAL, WHO HAVE FOR NOT LESS THAN TWO YEARS AT ANY TIME ATTENDED AS PUPILS AT A MAINTAINED PRIMARY SCHOOL, AND WHO, IN THE OPINION OF THE TRUSTEES, ARE IN NEED OF FINANCIAL ASSISTANCE.

Activities: Gives small grants to former pupils of Aberdovey, Pennal and Tywyn Primary Schools aged 16 years or over, going on to further education or apprenticeship.
