AFTER MAKING SUCH PAYMENTS THE INCOME TO BE USED IN ONE OR MORE OF THE FOLLOWING WAYS: (1) IN ASSISTING THE GOVERNORS OF THE SCHOOL (SEE CLAUSE 22) TO DEFRAY THE COST OF MEETING THEIR OBLIGATIONS UNDER THE EDUCATION ACTS 1944 TO 1976; (2) IN PROVIDING OR ASSISTING IN PROVIDING SUCH SPECIAL BENEFITS AT THE SCHOOL NOT NORMALLY PROVIDED BY THE LOCAL EDUCATION AUTHORITY; (3) IN PROMOTING THE EDUCATION OF CHILDREN ATTENDING THE SCHOOL IN SUCH WAYS AS THE TRUSTEES THINK FIT.

Activities: 1) Provision of land and buildings for Kirkbie Kendal School 2) Assist the Governors of the School to defray the cost of meeting their obligations under the Education Acts, as may be agreed by the Trustees.3) Providing special benefits which are not provided by the LEA
