Activities: In promoting the education of persons under the age of 25 who are resident or whose parents are resident in the parish of Suckley and who are in need of financial assistance in such ways as the trustees see fit in providing such special benefits of any kind not normally provided by the Government for Suckley Primary School, as may be agreed between the trustees and the Governors
