The only significant difference in income and expenditure in 2024-25 compared to 2023-24 was a £20,517 gain in the value of its investments (2023-24: £18,247 loss). At the 31 March 2024 £44,294 was held as restricted cash funds (31 March 2023: £37,797) and £287,492 as endowment funds (31 March 2023: £272,784).

Some of these charities were nominal in value with an annual income of only a few pounds and some were established for purposes or beneficiaries which no longer exist.</p> <p>The Council's Cabinet on 23rd April 2020 approved the transfer of the management the majority of these charities, including Chesterfield School Foundation, using the Revitalising Trusts Programme, to Derbyshire Community Foundation (operating as Foundation Derbyshire). The process of transferring the trusts has begun.</p>

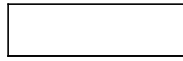
