Objects: (A)PROVIDING BOARD,POCKET MONEY,CLOTHING,TOOLS,INSTRUMENTS OR BOOKS,AND IN PAYING THE COST OF REASONABLE HOLIDAYS AND SPECIAL MEDICAL TREATMENT,FOR BENEFICIARIES WHO ARE ATTENDING ANY SCHOOL,UNIVERSITY OR OTHER PLACE OF LEARNING APPROVED BY THE PRINCIPALS;(B)AWARDING TO BENEFICIARIES SCHOLARSHIPS,BURSARIES OR MAINTENANCE ALLOWANCES TENABLE AT ANY SCHOOL,UNIVERSITY OR OTHER PLACE OF LEARNING APPROVED BY THE PRINCIPALS;(C)PROVIDING FINANCIAL ASSISTANCE,OUTFITS,CLOTHING,TOOLS,INSTRUMENTS OR BOOKS TO HELP BENEFICIARIES ON LEAVING SCHOOL,A UNIVERSITY OR ANY OTHER EDUCATIONAL ESTABLISHMENT TO PREPARE FOR,OR TO ENTER,A PROFESSION,TRADE OR CALLING;(D)AWARDING SCHOLARSHIPS OR MAINTENANCE ALLOWANCES TO ENABLE BENEFICIARIES TO TRAVEL ABROAD TO PURSUE THEIR EDUCATION;(E)PROVIDING,OR ASSISTING THE PROVISION OF,FACILITIES,OF ANY KIND NOT NORMALLY PROVIDED BY THE LOCAL EDUCATION AUTHORITY,FOR RECREATION AND SOCIAL AND PHYSICAL TRAINING,INCLUDING THE PROVISION OF COACHING IN ATHLETICS,SPORTS AND GAMES,FOR BENEFICIARIES WHO ARE RECEIVING PRIMARY,SECONDARY OR FURTHER EDUCATION;AND(F)PROVIDING FINANCIAL ASSISTANCE TO ENABLE BENEFICIARIES TO STUDY MUSIC OR OTHER ARTS.

Activities: To provide financial assistance by the way of pocket money, student and clothing allowance to children who have one or two deceased, disabled, separated or divorced parents.
