Objects: (A) PROVISION OF SPECIAL BENEFITS OF ANY KIND NOT NORMALLY PROVIDED BY THE LOCAL EDUCATION AUTHORITY FOR THE BURGH LE MARSH CHURCH OF ENGLAND PRIMARY SCHOOL (B) BENEFIT OF YOUNG PERSONS UNDER 25 YEARS OLD, RESIDENT IN THE BENEFICIAL AREA IN NEED OF FINANCIAL ASSISTANCE BY (I) PROVISION OF EXHIBITIONS, GRANTS OR MAINTENANCE ALLOWANCES TENABLE AT ANY INSTITUTION OF FURTHER EDUCATION. (II) FINANCIAL ASSISTANCE, OUTFITS, CLOTHING, TOOLS, INSTRUMENTS OR BOOKS TO HELP BENEFICIARIES ON LEAVING AN EDUCATIONAL ESTABLISHMENT TO PREPARE FOR, OR TO ENTER, A PROFESSION, TRADE OR CALLING. (III) APPRENTICING THEM TO SOME USEFUL TRADE OR OCCUPATION. (IV) IN OTHERWISE PROMOTING THEIR EDUCATION (INCLUDING SOCIAL AND PHYSICAL TRAINING)
