**Objects:** A) FINANCIAL GRANTS TO ASSIST PUPILS AND STUDENTS TO STUDY AND TAKE PART IN EDUCATIONAL ACTIVITIES AT SCHOOL, COLLEGE, UNIVERSITY (OR ANY SIMILAR INSTITUTION), OR TO STUDY AND TAKE PART IN EDUCATIONAL ACTIVITIES RELATED TO THOSE INSTITUTIONS.B) BY MAKING FINANCIAL GRANTS TO ASSIST PUPILS, STUDENTS AND YOUNG PEOPLE TO TAKE PART IN CLASSES OR OTHER ACTIVITIES OUTSIDE SCHOOL, COLLEGE OR UNIVERSITY (OR ANY SIMILAR INSTITUTION), WHEN THE CLASSES OR ACTIVITIES ARE BROADLY EDUCATIONAL IN NATURE, OR WHEN THEY PROMOTE SOCIAL OR PHYSICAL WELL-BEING.C) GRANTS SHALL ONLY BE MADE TO STUDENTS OR YOUNG PEOPLE WHOSE PRINCIPLE RESIDENCE IS IN THE PARISH OF CASTLE BYTHAM..

**Activities:** We make financial grants to assist young people in the parish of Castle Bytham to study and take part in activities, within or outwith educational institutions, so long as the study or the activities are broadly educational in nature, or when they promote social or physical well-being.
