Reads Exhibition Foundation started in 1927 and has evolved from an endowed building, the Reads Grammar School, which offered education and exhibitions to boys and girls wishing to further their education.

They now offer the provision of grants to children of Tuxford, Nottinghamshire for the purpose of education and further education.

- There cannot be less than three Trustees, but it has no upper limit.
- The Charity's business is managed by the Trustees, who may exercise the Charity's powers.
- The principal activity of the charity during the year was selling the building Reads Grammar School, Tuxford.

**OBJECTIVES AND ACTIVITIES**

Assisting pupils to obtain further education qualifications by attending schools' universities or other institutions other than elementary.

By assisting them to continue their education by learning the theory and practice of skilled trades.

Industries or employment by apprenticeship.

Otherwise promoting the education of poorer boys and girls in the parish of Tuxford including social and physical training.

Reads Exhibition Foundation (the Charity) has sold the Reads Grammar School Building and is restructuring to consider how best to use funds to meet the educational needs of a growing and changing community.


The sale of the building put the charity in a much more secure position as we go through restructuring,


