(F) THE EDUCATION OF ANY NECESSITOUS CHILD, OR DEPENDANT OF ANY SUCH PERSON MENTIONED IN (D). (G) THE EDUCATION OF ANY NECESSITOUS PERSON WHO IS SUCH A PERSON AS IS MENTIONED IN (D).
